It is expressly required that:

- each image must be accompanied by the original opera's specifications, ie: name of the author, title, technical and physical characteristics, origin and date. Again, each exemplar must contain the caption "Reproduced by concession of the University of Padua", as well as the explicit warning of the prohibition of further reproduction or duplication by any means;
- 2 copies of the publication/documentary must be sent to the Servizio Cerimoniale dell'Università di Padova, where they will be conserved and may be used for institutional purposes.

Acknowledge that under Article 12 of the University's Regulation, Padua University is exempt from any liability for damage to people or property, consequential or in any case arisen in connection with any authority's activity. This exemption also includes the reproduction activity and possible diffusion to the public of reproduced copies.
