Upon arrival in Padova admitted candidates have to contact as soon as possible the Enrolment Office, Via Venezia 13 (map: <http://www.unipd.it/ufficio-immatricolazioni>), e-mail segstud.titoliesteri@unipd.it. There is no entry or language test to pass, but for the enrollment is required the submission of the study documents in original version and of Embassy Application.

Required documents (original version):

- **Academic qualification**, translated into Italian and legalised, and “**statement of validity**” (**Dichiarazione di valore**).
- A certification, released by the competent academic authority, stating **which exams were passed**. The certification must be legalised and - if necessary - translated; English language is accepted.

Admitted candidates must **complete the enrolment application online from 24th July to 24th October 2017 12.00 a.m. (final deadline)** at the page https://uniweb.unipd.it/Home.do?cod_lingua=eng following the procedure indicated below:

Reserved Area → login: enter username and password

Home → Enrolment → Course Type “Second cycle degree”;

- Select the preferred course;
- Book the time and day in which to report to the Enrolment Office to finalise the registration;
- Complete the questionnaires provided;
- confirm and print out the registration application form and the MAV form for the payment of euro 561,00 (**only for candidates not admitted to the Call for applications for tuition fee waivers**) corresponding to the first instalment of tuition fees (the amount of instalments may be found at: <http://www.unipd.it/en/tuition-fees-scholarships-tax-relief-schemes>). Payment can be made at any bank branch in Italy.

Candidates must come to the Enrolment Office- Foreign Office - in Padua – Via Venezia 13, on the day and time of the appointment with the application form, photocopy of the **identity document** (the data entered in the enrolment application must correspond with those specified in the identity document), **two** identical passport-size photographs and the **original** receipt of payment of the first installment of tuition fees.

The following documents concerning the foreign qualification are required for the enrolment (original copy):

- **Academic qualification**, translated into Italian and legalised, and “**statement of validity**” (**Dichiarazione di valore**).
- A certification, released by the competent academic authority (Transcript of Records), stating **which exams were passed**. The certification must be legalised and - if necessary - translated; English language is accepted.
