# COMMON DATES AND DEADLINES

- Beginning of the academic year: **Tuesday 1 October 2024**
- Beginning of teaching activities: **Monday 30 September 2024**

The competent educational structures, giving notice via their website by Tuesday 27 August 2024, can bring forward the **start of educational activities to Monday 23 September 2024**.

The competent educational structures, **giving notice** via their website by **Monday 16 September 2024**, can **postpone** the start and end of educational activities.

If required by the procedures for admission to study courses with **restricted access at national level**, the teaching activities of these study courses **may begin after Monday 30 September 2024**.

The beginning of the lessons will be announced on the website of the school/department/course.

## ENROLLMENT AND ENROLLMENT FOR YEARS FOLLOWING THE FIRST

The enrollment dates for the first year of the courses (enrollments) are determined through the **Admission Notices**.

Enrollment in years subsequent to the first takes place **by Monday 30 September 2024** with the payment of the **first fee**.

Students who **graduate by Saturday 14 December 2024** are **exempt from paying the first fee**.

# PERIOD FOR SUBMITTING THE APPLICATION FOR ADMISSION TO THE FINAL EXAM

---

Students up-to-date with the payment of fees can submit the application for admission to the final exam by the following dates:

## **FIRST PERIOD - GRADUATIONS FROM MONDAY 17 FEBRUARY 2025 TO THURSDAY 17 APRIL 2025**

- Deadline for graduation application: from Monday 18 November 2024 to Tuesday 21 January 2025
- Deadline for taking exams: 15 days before the start of the graduation session
- Payment of fees: first and second fee 2024/25

## **SECOND PERIOD: GRADUATIONS FROM WEDNESDAY 18 JUNE 2025 TO FRIDAY 25 JULY 2025**

- Deadline for graduation application: from Monday 24 February 2025 to Tuesday 6 May 2025
- Deadline for taking exams: 15 days before the start of the graduation session
- Payment of fees: first, second and third fee 2024/25

## **THIRD PERIOD A: GRADUATIONS FROM MONDAY 1 SEPTEMBER 2025 TO SATURDAY 25 OCTOBER 2025**

- Deadline for graduation application: from Wednesday 18 June 2025 to Tuesday 15 July 2025
- Deadline for taking exams: 15 days before the start of the graduation session
- Payment of fees: first, second and third fee 2024/25

## **THIRD PERIOD B: GRADUATIONS FROM MONDAY 3 NOVEMBER 2025 TO SATURDAY 13 DECEMBER 2025**

- Deadline for graduation application submission: from Monday 18 August 2025 to Tuesday 7 October 2025
- Deadline for taking exams: 15 days before the start of the graduation session
- Payment of fees: first, second and third fee 2024/25

The graduation sessions and the deadlines for submitting the graduation application of the courses in the **Health Professions** are established by the competent educational structures, having acquired the ministerial indications.

## PLEASE NOTE

- The **dates** of the individual graduation sessions must be established and **communicated by the competent educational structures** to the Student Career Office at least **30 days** before the announcement date.
- Students enrolled in a Degree Course in **Health Professions** (Classes 1-4SNT), who **obtain the title** in a **graduation session starting by Wednesday 30 April 2025** and who have acquired all the certificates of attendance by the month of September 2024, are exempt from paying the **first fee** for the **a.y. 2024/2025**.
- Students enrolled in the last year of a course of study with **regulations prior to the D.M. 509/99** who **graduate by Wednesday 30 April 2025** are **exempt** from paying the **first fee** for the **a.y. 2024/2025**.
- To be admitted to the final exam, it is **mandatory to make all payments** due **within seven days** prior to the date of the graduation session (Student Career Regulations, art. 24).

# PERIODS OF LESSONS AND PROFIT ASSESSMENTS

## 3.1 ACTIVITY ON QUARTERS

Each course of study must provide **at least 9 weeks** of effective educational activity within the periods indicated. The formal fulfilments of verbalization/registration of the profit assessments for the study courses according to the D.M. 509/99 and 270/04 can begin before the start of the two official exam sessions, at the end of the 9 weeks of face-to-face activity.

### FIRST QUARTER

- Teaching: from Monday 30 September 2024 to Saturday 30 November 2024
- Profit assessments: from Monday 2 December 2024 to Saturday 21 December 2024

### SECOND QUARTER

- Teaching: from Tuesday 7 January 2025 to Saturday 15 March 2025
- Profit Assessments: from Monday 17 March 2025 to Saturday 5 April 2025

### THIRD QUARTER

- Teaching: from Monday 7 April 2025 to Saturday 14 June 2025
- Profit assessments: from Monday 16 June 2025 to Saturday 19 July 2025

### RECOVERY

- Profit assessments: from Monday 18 August 2025 to Saturday 20 September 2025

## 3.2 ACTIVITY ON SEMESTER

Each course of study must provide **at least 12 weeks** of effective teaching activity within the periods indicated. The formal fulfilments of verbalization/registration of the profit assessments for the study courses according to the D.M. 509/99 and 270/04 can begin before the start of the two official exam sessions, at the end of the 12 weeks of face-to-face activity.

### FIRST SEMESTER

- Teaching: from Monday 30 September 2024 to Saturday 18 January 2025
- Profit Assessments: from Monday 20 January 2025 to Saturday 22 February 2025

### SECOND SEMESTER

- Teaching: from Monday 24 February 2025 to Saturday 14 June 2025
- Profit assessments: from Monday 16 June 2025 to Saturday 19 July 2025

### RECOVERY

- Profit assessments: from Monday 18 August 2025 to Saturday 20 September 2025

### SESSION FOR GRADUATING BY 13 DECEMBER 2025

- Profit Assessments: from Wednesday 1 October 2025 to Saturday 22 November 2025



For the **Health Professions** degree courses, the educational activities are planned allowing for the carrying out of professional internships in compliance with community regulations and ministerial indications.

The lessons of the first year of the Master's Degree Courses in Health Professions and of the single-cycle Master's Degree Course in Medicine and Surgery begin after the enrollment of the candidates, based on the date of the admission test set by Ministerial Decree

**DEGREE COURSES: DIETETICS, NURSING, BIOMEDICAL LABORATORY TECHNIQUES, MEDICAL RADIOLOGY IMAGING TECHNIQUES AND RADIOTHERAPY, HEALTH ASSISTANCE, OCCUPATIONAL THERAPY.**

### **FIRST SEMESTER**

- Teaching: from Monday 30 September 2024 to Saturday 11 January 2025
- Profit assessments: from Monday 13 January 2025 to Saturday 1 February 2025

### **SECOND SEMESTER**

- Teaching: from Monday 3 February 2025 to Wednesday 25 June 2025
- Profit assessments: from Thursday 26 June 2025 to Saturday 26 July 2025\*

### **RECOVERY**

- Profit assessments: from Monday 18 August 2025 to Saturday 20 September 2025

### **SESSION FOR GRADUATING BY 13 DECEMBER 2025**

- Profit Assessments: from Wednesday 1 October 2025 to Saturday 22 November 2025

\*For the "Nursing" degree course extension of the second period of profit assessments to Saturday 2 August 2025.

## 3.3 FINAL EXAM

In each of the three periods it is mandatory to provide at least one call unless otherwise stated in ministerial decrees.

### **STUDY COURSES EX D.M. 509/99 AND 270/04**

- First period - from Monday 17 February 2025 to Thursday 17 April 2025
- Second period - from Wednesday 18 June 2025 to Friday 25 July 2025
- Third period A+B- from - Monday 1 September 2025 to Saturday 13 December 2025

### **COURSES OF STUDY PRIOR TO THE D.M. 509/99**

- Extraordinary session a.y. 2023/24 - from Monday 17 February 2025 to Thursday 17 April 2025
- Summer session - from Wednesday 18 June 2025 to Friday 25 July 2025
- Autumn session - from Monday 1 September 2025 to Saturday 13 December 2025

## PLEASE NOTE

- The competent teaching structures can authorize teachers to open extraordinary exam sessions outside the periods established above, to students outside the course of the system prior to the Ministerial Decree 509/99 and to repeating students of D.M. 509/99 and 270/04, provided that this does not interfere with normal teaching activities
- For study courses activated in inter-university mode with foreign universities (issue of double degree or joint degree), the competent teaching structures can provide for assessments of profit and for the final exams, extraordinary sessions outside the periods established above.
- The graduation sessions and the deadlines for submitting the graduation application for the health professions degree courses are set by the competent teaching structures, having acquired the ministerial indications, taking into account the needs of the University educational planning.
