


The fourth Urban Innovation and Entrepreneurship Competition sponsored by the Alliance of Guangzhou International Sister-City Universities and hosted by the University of Padova will be held from March to November 2023.

The competition is promoted by members and affiliate members of the Alliance of Guangzhou International Sister-City Universities.

The theme of the competition is Promoting Sustainable Urban Development with Scientific and Technological Innovation, focusing on Science Entrepreneurship.

Competition Finalists will be judged by the following criteria, but not limited to:

- Innovation
- . Team
- Commerciality
- Social Benefits
- Communication







Eligible Participants

Eligible participants are **full-time students over 18 years old or graduates within 5 years of graduation** (graduates after 2018) from GISU members and affiliate member universities. Each team must have **at least two participating members** and must be actual members of the project. The principal applicant will be considered as the team leader.

Based on different projects and categories, competition groups include:

- **CONCEPT TEAMS:** Members of the team have not funded a company, but have a business idea or project.
- START-UP TEAMS: Members have launched a start-up company. The company must not have been established before 2021. The equity of the legal representative of the participating enterprise shall not be less than 10% and the total equity of the participating members shall not be less than 1/3. The corporate legal representative shall not be allowed to make changes after the announcement of the contest.

Project Requirements

Registration for the forum and competition must come as a team. Multi-disciplinary, inter-professional, inter-university, and multi-national teams are encouraged. Each team must have at least two participating members and must be actual members of the project.

The GISU member university where the project leader is currently enrolled will be taken as the home university of the project.


The entries must be real, legal, and in good standing without any negative records. Plagiarism, misappropriation, provision of false materials, or violation of relevant laws and regulations will result in the project team immediately losing rights to participate and will bear all legal responsibilities.

For start-up projects that have completed company registration, the company profile and legal representative status, shareholding structure, and copies of other relevant certification documents must be provided *during the in-school competition to the relevant university.*


SEMI-FINAL COMPETITION 10 July 2023, ONLINE

The expert judges will select 12 teams per category to compete in the final. The finalists will be announced on 10 July 2023.

All semi-finalist winners, unless the team notifies the finalist competition committee otherwise, will automatically be entered into the China International College Students' "Internet+" Innovation and Entrepreneurship Competition which is the world's largest innovation and entrepreneurship competition for college students.

Certificates and Training Opportunities



All semi-finalists will receive a participation certificate and appreciation letter provided by the Alliance.

Online course will be offered to semi-finalists with the aim to improve their performance for the final competition:

- How to prepare and manage a short presentation
- How to prepare a business plan for a start-up
- Introduction to Lean start-up

The above courses are not mandatory, but strongly recommended.












Judges and Crediting Rules






Judges of the in-school preliminary competition are selected by each GISU member university.

Judges of the online semi-final competition and the final will be selected by the organizing committee under the supervision of the Alliance Secretariat Office.




