3) PURPOSES OF AND LEGAL BASIS FOR DATA PROCESSING

- The data you provide will be exclusively used to register your company on internship and placement, career day and mentoring portals and to enable your company to access the services offered by the Career Service of the University of Padova;
- The data your provide us which is marked with * is mandatory in order to register your company on our portal. As a result, if you do not provide us with this information, your company cannot be added to our portal and you will not be able to access the services offered by the Career Service of the University of Padova;
- Please note that in any case your data will be processed only to provide you with this service, pursuant to art. 6, par. 1, sec. B) of EU Regulation 2016/679;
- Data not marked with * is optional and and such it is not necessary to register your company, but it is used by the Career Service to improve the service offered;
- Data will be processed only if you give your consent to do so, pursuant to art. 6, par. 1, sec. a) of EU Regulation 2016/679. You may withdraw your consent at any moment without affecting the data already processed.

4) RECIPIENTS OR RECIPIENT CATEGORIES:

The recipients of your personal data are the Controller and any Processors appointed by the Controller, as well as any natural persons tasked with processing your data for the aforementioned purposes.
