#### Preface

The University of Padua, within the Erasmus+ Key Action 1 Virtual Exchange project "CliVEx - Climate Virtual ExChange: Enhancing climate awareness in Europe and the Southern Mediterranean Area" (101111937 – CliVEx – ERASMUS-EDU-2022-VIRT-EXCH), opens a call for 30 places for virtual exchange from 14<sup>th</sup> October to 20<sup>th</sup> December 2024.

Among the project activities, the implementation of the virtual exchange "Climate Justice: From Inequality to Inclusion" is foreseen. The programme is designed and delivered in collaboration with UNIMED - Mediterranean Universities Union (Italy), An-Najah National University (Palestine), Lebanese International University (Lebanon), Sharing Perspectives Foundation (The Netherlands), and Association Soliya (Tunisia).

### Art.1 – General information

#### 1.1. Purpose

Erasmus+ is the programme from the European Union for education, training, youth and sport, in effect between 2021 and 2027.<sup>1</sup>

The present Call regulates some activities implemented in the framework of the Erasmus+ Key Action 1 Virtual Exchange project "CliVEx - Climate Virtual ExChange: Enhancing climate awareness in Europe and the Southern Mediterranean Area", which allows university students enrolled at least in the second year of higher education studies to participate in a virtual exchange programme.

#### 1.2. Eligible activities

Places are allocated for the virtual exchange<sup>2</sup> programme "Climate Justice: From Inequality to Inclusion". The programme aims to foster the development of transversal skills, such as: intercultural communication and awareness, team-working, digital and linguistic competences, civic engagement, awareness on the topics of sustainability and climate change, in order to promote professional and personal growth and students' entry into the labour market. The programme is scheduled over 10 weeks, when students will work on intercultural and multidisciplinary teams on a "climate action" project.

For the virtual exchange, students will gain 3 ECTS<sup>3</sup> credits from the University of Padua as other activities<sup>4</sup>, once the course unit "Climate Justice: From Inequality to Inclusion" has been added to the student's booklet. The possibility to have those credits added as a curricular activity is not granted, whereas the possibility to have those credits added as an extra-curricular activity is always possible. Students are invited to enquire in advance about any restrictions and rules for their specific Degree Programme and, in case of doubt, to contact the President of their Degree Programme or their delegate for confirmation.

#### 1.3. Duration

The duration of the virtual exchange is 10 weeks, from 14<sup>th</sup> October to 20<sup>th</sup> December 2024.

#### **1.4.** Students with disabilities and learning difficulties

Students with disabilities and learning difficulties (DSA) who intend to participate in the Erasmus+ virtual exchange can highlight this during the application submission process. Their situation will then be taken care by the Projects and Mobility Office together with the Student Service Office, if they are selected to participate in the CliVEx Programme. The selection criteria are the same for all students.

# Art.2 - Admission Pre-Requisites and Application Procedure

#### 2.1 Admission Pre-Requisites

Students are admitted to participate in the program if, upon applying and for the entire duration of the program, they are in the following conditions:

- Being registered at the University of Padua in a degree course (ex DM 509/99 or 270/2004), bachelor's course, master's course, single-cycle master's course;
- 2. Not being registered in the first year of a Bachelor's degree programme (firstcycle degree) for the a.y. 2024/25;
- 3. Not being 30 year-old or older5;
- 4. Not being registered in single course units;
- 5. Not being incoming exchange students at the University of Padua;
- 6. Not having already taken the course "Climate Justice: From Inequality to Inclusion" in one of its previous iterations;
- Students must prove their proficiency in English through a certificate attesting a minimum B2 level (Common European Framework of Reference for Languages) or they must be enrolled in a Bachelor's degree, Master's degree or Single-cycle degree programme delivered in English or have successfully completed it.

### Art.3 - Contributions and financial benefits

There are no fees to participate in the programme, as the virtual exchange is held fully online.

# Art. 4 – Application procedure

Students that want to apply for the virtual exchange "Climate Justice: From Inequality to Inclusion" must submit their application exclusively via the dedicated Google Form (<u>https://forms.gle/T3a58B6GksAcRYbf6</u>) NO LATER THAN 1.00 PM (Italian time) ON 19<sup>th</sup> SEPTEMBER 2024.

With the application one must attach, in PDF format, the following documents:

- 1. copy of the language certificate or another document attesting the applicant's language level;
- only for students enrolled in the first year of a Master's degree programme: copy of the Bachelor Transcript of Records or Diploma Supplement;
- only for students enrolled in Erasmus Mundus Joint Master Degrees, double / multiple / joint degree programmes: copy of the Transcript of Records with mention of the exams taken in the different Universities of the programme;
- 4. motivation letter written in English (maximum 2000 characters, spaces included);
- 5. any additional qualifications which may be relevant to the analysis by the Committee (e.g. curriculum vitae, other certificates, etc).

# Art. 5 – Selection criteria

Students will be ranked in accordance with selection criteria regarding their proficiency in English, their merit coefficient<sup>6</sup>, their motivation letter and additional qualifications.

In case of candidates with equal assessment, priority will be given to the student who has not already benefited from funding for international mobility, in line with the aims of the project. In case of further equal scores, priority will be given to the student enrolled in a Master's degree programme and, should the equal scores still subsist, to the one enrolled in a less represented degree course in the ranking list. Younger ages will be used as additional criterion in case of further equal scores. Should the number of applications received be higher than 100, the Committee reserves the right to run a pre-selection considering the merit coefficient only. Then, only the first 100 applications will be assessed against the other criteria.

# Art. 6 – List of successful students

#### 6.1 Lists of successful students and accepting the place

A dedicated Committee will analyse the applications and select students.

Should the Committee deem it necessary, a face-to-face or online interview may be arranged: if this is the case, candidates will be notified of the time and place of the interview. Failing to attend the interview will result in the automatic exclusion of the candidate from the selection.

Once the Committee has finalised its task, the list of successful candidates will be published from 30<sup>th</sup> September on the webpage: <u>https://www.unipd.it/clivex</u>. Successful candidates will also be informed via email.

Successful candidates must declare that they are accepting their place confirming via email to <u>virtual.exchange@unipd.it</u> before the date that will be communicated. In the event that the place is not accepted within the outlined dates, the students will automatically be considered 'renouncing'.

#### 6.2 Reserve places

Places that are not accepted by successful candidates will be assigned to those next in line on the list. Due information will be given via email. In the event that the place is not accepted within the deadlines given, the student will be considered 'renouncing' and the place will be assigned to the next student in line on the list or remain unassigned.

# Art. 7 – Procedures for successful students

The detailed procedures for successful students will be communicated via email to the selected candidates after the conclusion of the selection process.

# Art. 8 – Recognition of activities

Only for selected students, CliVEx (i.e. "Climate Justice: From Inequality to Inclusion") can be added as a 3 credit-bearing activity. The inclusion in the study plan is not guaranteed and requires approval by the President and the Student Office of the student's degree course. Details will be communicated via email to the selected candidates.
