# SIMULTANEOUS ENROLMENT WHILE AWAITING GRADUATION

## Bachelor's, Single-cycle, Master's degree programmes

Below is a summary of the procedures for accessing the degree programmes, the boxes are clickable and refer to the reference pages. The instructions in this document refer to the **cases highlighted in green**.

## 1. Students graduating at the University of Padua

In order to submit the application for limited simultaneous enrolment in the academic year 2025/26, it is necessary to graduate in the degree programme that is being completed **within the graduation sessions scheduled for academic year 2024/25**.

**Please note: you cannot** submit the application for limited simultaneous enrolment to access a **Master's degree** programme if the degree programme you are concluding is the Bachelor's or Single-cycle degree programme that you will use to access the Master's degree programme.

For those who graduate during the fall/winter 2025, some Master's degree programmes have an additional enrolment period: this possibility, the related procedures and deadlines can be found in the relevant Call for admissions: [www.unipd.it/avvisi-ammissione-corsi](http://www.unipd.it/avvisi-ammissione-corsi)

Once admission to the degree programme has been obtained as per the Call for admission, within the enrolment deadlines, the request must be submitted to [pratiche.immatricolazioni@unipd.it](mailto:pratiche.immatricolazioni@unipd.it), with the subject: "LIMITED COMPATIBILITY UNIPD + [name of the degree programme]" (for example: "LIMITED COMPATIBILITY UNIPD Information Engineering")

- Copy of a valid identity document (back and front)
- Receipt of payment of the first instalment of the fees for academic year 2025/26 of € 205.00. Payment must be made by selecting the reason for payment "DIDA21 - First/second/single cycle degree enrolment fee" on the portal

- Only for those who have been **admitted to a year subsequent to the first**: credit recognition deliberation, stating that you have obtained the proposed admission to a year subsequent to the first

If you do not fall within the cases provided for simultaneous enrolment in two degree programmes (as reported on page [www.unipd.it/contemporanea-iscrizione](http://www.unipd.it/contemporanea-iscrizione)) or if the condition for the limited simultaneous enrolment is not met, you will be required to choose which of the two careers to continue and which to close.

## 2. Students graduating at other Italian or foreign universities

In order to submit the application for limited simultaneous enrolment in the academic year 2025/26, it is necessary to graduate in the degree programme that is being completed **within the graduation sessions scheduled for academic year 2024/25**.

**Please note: you cannot** submit the application for limited simultaneous enrolment to access a **Master's degree** programme if the degree programme you are concluding is the Bachelor's or Single-cycle degree programme that you will use to access the Master's degree programme.
