## Additional funding to the Erasmus+ for studies beyond Europe Grant

#### a) Contribution to tavel costs

ISEE certificate submitted after the 22nd July 2020 and with irregularities will be not considered valid.

Students from the second-year *fuori corso* <sup>1</sup>will not receive any additional funding..
