Announcement of competition to award the scholarship in memory of Giordano Sanginiti First Edition 2024

Recitals

The University of Padova, following funding donated by the *Associazione Giordano nel cuore APS*, is announcing a competition for the assignment of **a study awards of 3.500.00 Euros** in order to encourage and support in a tangible way the attendance of a student at the University of Padova's single-cycle degree courses in *Medicina e Chirurgia* and *Medicine and Surgery*.

Art. 1 Requirements to be admitted to the competition

The award is assigned to students who are enrolled for the A.Y. 2023/24 at the first year of the University of Padova's single-cycle degree courses in *Medicina e Chirurgia* and *Medicine and Surgery*.

Applicants also need to meet the following requirements:

- a) be under 25 years of age on the date of the deadline of this announcement;
- b) possess an ISEE 2024 for the right to university study, non-divergent and not exceeding 35,000.00 Euros;
- c) finalize enrollment in the second year of the course in A.Y. 2024/25 by making payment of the first installment by September 30, 2024;
- d) have earned at least 20 CFUs by September 30, 2024 (credits recognized from previous careers are not counted).

The study award is compatible with the regional scholarship awarded for the a.y. 2023/24. Therefore, students found to be eligible for but not awarded a regional scholarship for A.Y. 2023/24 as of the deadline of this announcement may apply.

Art. 2 How to submit the application and deadlines for submission

The application must be submitted no later than **October 15th, 2024** through the dedicated Moodle platform (<https://elearning.unipd.it/ufficiiserviziapplicazioni> - *Area Didattica e Servizi agli studenti – Ufficio Servizi agli studenti – Settore benefici economici – Premi di studio per studenti*).

Applicants can access with SSO (Single Sign On) credentials issued by the University of Padua. Who do not have such credentials are required to send an email to premi.studenti@unipd.it (specifying their name, surname, email address and by attaching a copy of a valid ID document), and will receive within a few days the notification of registration to Moodle platform, with the access credentials.

When applying, candidates must strictly follow these steps:

- read the competition notice;
- fill in the application form;
- attach the required documents;
- confirm the application by placing a final check mark.

The following documents must be attached to the online application, under penalty of exclusion from the competition:



1. Curriculum vitae and academic curriculum;
2. Copy of a valid ID document.
3. ISEE 2024 certificate issued for benefits related to the right to university studies, without omissions and/or discrepancies, not exceeding 35,000.00 €, only if the Application for Benefits for the academic year 2024/25 has not been filled in (if you want to use a current ISEE, the relevant certificate must be upload);
4. motivational letter.

Any application which does not meet all these requirements will not be taken into consideration. By participating in this competition, the applicant fully accepts these regulations. Any falsified documents and/or mendacious statements will result in the applicant being excluded from the competition or in the right to compensation if the award has already been assigned.

Applications received after the deadline will not be considered.

Art. 3 How scholarships are awarded

The University of Padua will proceed to verify compliance with the requirements of this announcement. With regard to the requirement concerning one's economic situation, the ISEE value used for the purpose of determining the university contribution for the academic year 2024/25, as resulting from the Application for Benefits submitted by the candidate, will be considered. In the case of failure to submit this Application, or in case one intends to use the current ISEE, the candidate must attach to the application the ISEE 2024 certificate for the right to university study, without omissions and/or discrepancy, under penalty of exclusion from the competition.

The award will be assigned following the ranking of the applications as determined by the Evaluation Committee appointed by the Rector. The Evaluation Committee will include two University representatives and a representative from *Associazione Giordano nel cuore APS*.

The ranking of the applications will be based on the following criteria:

- academic merit: grade point average and CFUs earned and recorded by September 30, 2024 (career data acquired from the office);
- income: economic situation of the candidate's household, based on the declared ISEE;
- additional elements deduced from the CV and motivational letter.

Winning applicants will be informed of the award with an email sent to the account specified in the registration process. The result of the competition will also be published on the University of Padua website at www.unipd.it/archivio-borse-premi-studio-studenti.

The curriculum vitae of the winners will be published in the "Amministrazione trasparente" section of the website of the University of Padua, pursuant to art. 27, c.1, letter F), Legislative Decree no. 33/2013 *Riordino della disciplina riguardante il diritto di accesso civico e gli obblighi di pubblicità, trasparenza e diffusione di informazioni da parte delle pubbliche amministrazioni* (Reorganization of the rules concerning the right of civic access and the obligations of publicity, transparency and dissemination of information by public administrations).

Art. 4 Scholarship amount and how it is paid

The amount of the study award is of € 3,500.00, including expenses paid by the institution (I.R.A.P.) and will be paid by the competent university office.



Art. 5 Person in charge of the administrative process

Pursuant to art. 4 of law 241 of 7 August 1990 (New norms on administrative procedures and right to access administrative documents), Dr. Alessandra Biscaro, Head of the Student Service Office is appointed to oversee the administrative procedure.

Candidates may exercise their right to access the competition records following the procedures set forth by Presidential Decree no. 184 of 12 April 2006 (Regulation on accessing administrative documents in compliance with item V of law 241/90).

Art. 6 Personal data processing

The personal data collected for the purposes outlined in this announcement of competition is processed in compliance with EU Regulation no. 679 of 27 April 2016 (General Data Protection Regulation, GDPR).
