## PREMISE

The present “Call for applications for Tuition Fees and Fee-waivers” lays down the criteria for tuition fees charged to students enrolled in Bachelor’s, Master’s, and Single-cycle degree programmes (hereafter “degree programmes”) of the University of Padua (hereafter “University”), as well as payment methods.

Different fee-waiver options reserved for specific categories and refunds procedures are also detailed.

Students who wish to benefit from the services offered by the University must regularly pay their university fees, which are payable in three instalments per academic year.

## 1. TUITION FEES

Fees charged to each student enrolled in a degree programme are calculated on income, merit, and students’ personal situation.

The maximum overall amount of tuition fees for A.Y. 2021/22 (see **Table 1**) is calculated by adding up:

**A) the full tuition fee** (which varies according to the degree programme);

**B) the regional tax and the stamp duty.**

Annex 1, which is an integral part of this call for applications, lists the degree programmes by 3 groups, established by the University.

The actual amount due is calculated on the **Application for benefits** submitted on UNIWEB and the issuance of the ISEE for benefits related to the right to higher education (see section 2 of this call).

A **simulator** to calculate the estimated tuition fee for academic year 2021/22 (including any increase charged to students behind with their studies) is available at: [www.unipd.it/en/fees-simulator](http://www.unipd.it/en/fees-simulator).

The overall amount due is payable in **3 instalments**, which cannot be further deferred.

### ✓ FIRST INSTALMENT

Enrolments in academic year are finalised upon paying the **FIRST INSTALMENT** of tuition fees, which **amounts up to**:

a) **€ 189.00** for **first year** enrolments in degree programmes, composed of:

- € 173.00: regional tax for the right to higher education;
- € 16.00: stamp duty.

The amount of the full tuition fee due is divided between the second and third instalment.

Payment must be made **upon enrolment**, in accordance with the procedures and deadlines laid down in each call for applications.

b) **€ 569.00** for enrolments in **years subsequent to the first** of degree programmes, composed of:

- € 380.00: part of the full tuition fee;
- € 173.00: regional tax for the right to higher education;
- € 16.00: stamp duty.

Payment must be made **by 30 September 2021**.

- c) € 16.00 for students enrolling in **years subsequent to the first** of degree programmes, deemed eligible for regional scholarships for A.Y. 2020/21 and students with a disability level between 66% and 100% or with a disability recognised as per Law 104. Only the stamp duty is made payable.

Payment must be made from **by 30 September 2021**.

NB: Upon publication of merit lists, students not applying or not eligible for regional scholarship for A.Y. 202/22 will find the settlement of the first instalment, to be paid **by 30 November 2021**, in the Payments section on Uniweb.

The first instalment is **not charged** to students who graduate **by December 2021**, as graduation sessions relate to A.Y. 2020/21.

### ✓ **SECOND AND THIRD INSTALMENT**

The overall amount of the **SECOND** and **THIRD INSTALMENT** corresponds to the remaining part of the full tuition fee due and not included in the first instalment, divided in half.

The amount of the full tuition fee, which is subject to increase for students behind with their studies, depends on the degree programme, the ISEE value and any exemption applied.

The regional tax for the right to higher education varies according to the ISEE and it ranges from a minimum of € 131.00 to a maximum of € 173.00 (**Table 5**).

The **second instalment** is due by **15 February 2022**.

The **third instalment** is due by **16 May 2022**.

## **2. HOW TO APPLY FOR ECONOMIC BENEFITS**

In order for students enrolled to obtain economic benefits, the following two steps are to be made within and not later than the deadlines mentioned below:

A. filling in and confirming the **Application for benefits** on UNIWEB

B. applying for the **ISEE for the Right to Higher Education**

A. The **Application for benefits (Richiesta di Agevolazioni - "RdA")** is the self-certification students must fill in and confirm in order to get a reduction in their tuition fees. By applying for benefits, students authorise the University to acquire their ISEE (*Indicatore Situazione Economica Equivalente - Equivalent Economic Status Index*) from the INPS database.

- ✓ **WHERE:** the application form is available **online, in the student's personal area on Uniweb**, by clicking on "Right to university studies, disability disclosure, summer courses", from the **12 July 2021**.

Students can fill in the Application for benefits by simply registering into the UNIWEB portal, with no need to be already enrolled. **The above-mentioned deadline applies even to students enrolling during the year (enrolments in Master's degree programmes, transfers from another university, etc..).**

- ✓ **VERIFICATION TOOLS:** once the application has been filled in, it must be definitively confirmed, under penalty of invalidity of the Application. Students receive a confirmation email both to their personal and institutional email address (if already active) attesting the application has been received. A second confirmation email will be sent once the ISEE data has been acquired.

- ✓ **IN CASE OF MISTAKE:** once confirmed, the Application for Benefits for the reduction of the tuition fees can be modified directly by the student through the same online procedure by 30 November 2021 (or by the closest deadline in the case of a request for benefits, such as a scholarship).

B. To **get their ISEE certificate**, students must submit the DSU self-certification ("Dichiarazione Sostitutiva Unica") either online through the INPS' website, or in person by going to a Tax Assistance Centre (Centro di Assistenza Fiscale - CAF) or other relevant organizations. Please note that ISEE certificates are issued up to 10 working days after the

DSU has been submitted. To this end, please note that the date shown on the receipt of presentation of the DSU will be valid and not the date of issue of the ISEE certificate.

- ✓ **WHICH ISEE TO ASK FOR: the University can acquire and accept only the ISEE for the Right to Higher Education (ISEE per le Prestazioni Agevolate per il Diritto allo Studio Universitario)** on behalf of the student who is to benefit from the reduction (in case of two or more students from the same household, the Tax Identification Number of each student applying for the benefit must be included).

The ISEE must be **valid**, meaning it cannot be expired on the date of confirmation of the Application for benefits on UNIWEB.

In cases where the ISEE has not been issued for the right to higher education or ISEE expired on the date of confirmation of the Application for benefits on Uniweb, students must apply for a new one within the deadlines hereinafter specified.

The student is required to verify that on the ISEE certificate **there are no omissions and/or discrepancies**, under penalty of non-application of the requested benefit.

If there are any omissions and/or discrepancies, a new DSU must be promptly submitted, including the information previously omitted or otherwise stated, within the established deadlines.

The University predisposes appropriate checks, through its affiliated Caf, and in the event of an untruthful declaration the relative sanction will be applied.

**CURRENT ISEE:** if the conditions laid down in the relevant legislation are met, it is possible to apply for a current ISEE. The relevant DSU must in any case be signed by the deadlines hereinafter specified, and the certificate must have the above-mentioned features. Students who wish to apply for it to have fees reduced should email [benefici.studenti@unipd.it](mailto:benefici.studenti@unipd.it).

**ISEE PARIFICATO FOR INTERNATIONAL STUDENTS:** a different certification is needed for:

- foreign students residing abroad and whose family unit resides abroad;
  - foreign students residing in Italy, whose income is less than € 6,500.00 and whose family unit resides abroad;
  - Italian students residing abroad, whether registered or not in the Registry of Italians Residing Abroad (AIRE).
- Students can apply for ISEE Parificato only to a CAF with an agreement in place with the University.

- ✓ **WHEN: by 30 November 2021** (beyond this deadline the maximum amount provided for in Table 1 will be applied).

The data on the ISEE certificate, if valid, with no omissions and/or discrepancies, and issued for the right to higher education on behalf of the student, will be automatically acquired from the INPS database (or from the CAF with an agreement in place with the University, in the case of ISEE Parificato), following authorization granted by the student in the RdA. **Once the ISEE has been acquired and its validity has been verified, the procedure will automatically recalculate the instalments due, in a couple of days.**

**NB:**

Students enrolling in years subsequent to the first and making these two mandatory steps **by the 30 September 2021** can have the first instalment recalculated in advance and pay the already reduced amount by the deadline. The reduction of the first instalment is applied to students whose recalculated annual full tuition fees is lower than € 380.00

- ✓ **AFTER THE DEADLINE:** it is possible for students to have the instalments recalculated on the ISEE and other fee-waivers even after the deadline, by paying a late submission fee of:

- € 109.00 for DSU signed and/or Applications confirmed between **1 December and 15 February 2022**;
- € 218.00 for DSU signed and/or Applications confirmed between **16 February and 16 May 2022**.

The procedure remains unchanged; following acquisition of ISEE and automatic fee recalculation, the amount of the late submission fee due, uploaded into UNIWEB, is to be paid separately and within the deadline for registering for graduation.

**No fee reductions will be granted later than 16 May 2022.**

The above-mentioned deadlines also apply to students enrolling during the year (e.g. students awaiting publication of ranking list for admission).

### 3. PAYMENTS AND REFUNDS

Students are fully complying with university fee rules when all tuition fees due in both current and previous academic years have been settled, including late payment fees and fees resulting from full or partial revocation of fee-waivers.

Payments must be made using the **PagoPa** method exclusively, detailed information on the web page [www.unipd.it/en/pagopa](http://www.unipd.it/en/pagopa), which students can access by logging in to their personal area on Uniweb and clicking on "Right to university studies, disability disclosure, summer courses", Payments section.

Students should check payment confirmation in the same section. No other payment methods are allowed.

Should the University owe students money, following payment of instalments in full before any fee reduction and/or fee-waivers were applied, refunds are given by the academic year.

Refunds will be credited to students' bank account or prepaid card, provided the bank account number (IBAN) has been entered into students' personal area on Uniweb ("Home, Master Data, Refund methods, Edit Bank Account Refund Data"). Students must be holders or joint holders of the bank account or the prepaid card; bank account numbers of third parties, parents included, are not accepted.

In the event of students residing abroad, their Italian address must be entered into personal area on UNIWEB, under "Home, Master data, Modify domicile address"; if not, no refunds will be possible.

### 4. INCOME-BASED REDUCTIONS, AND EXEMPTIONS BY LAW

#### A. EXEMPTIONS BY LAW (Law 232/2016 - Ministerial Decree 234/2020 – Law 178/2020) and UNIPD EXTRAORDINARY EXEMPTIONS

Pursuant to regulations in place (Law 232/2016, Ministerial Decree 234/2020 and Law 178/2020), the University applies the graduation of the annual tuition fee based on the enrolment and income conditions of students who, in the case of enrolment in the second academic year, have earned, by the date of August 10, 2021, **at least 10 ECTS credits**; in the case of enrolment in academic years subsequent to the second, have earned, in the twelve months prior to the date of August 10, 2021, **at least 25 ECTS credits**. Merit is not considered in the case of enrolment in the first year.

Students in **possession of the above-mentioned merit requirement and enrolled for a number of academic years lower than or equal to the normal duration** of the degree programme, increased by one, who belong to:

- a family unit whose **ISEE is lower than or equal to € 24,000** is **totally exempted from the annual full tuition fee** (against an "extraordinary extension" of the total exemption for the band from € 20,000 to € 24,000;
- a family unit whose **ISEE is between € 24,001 and € 30,000**, are subject to a gradual exemption from the annual full tuition fee. Specifically, the graduation according to Law 232/2016 provides that this contribution does not exceed 7% of the share of ISEE exceeding € 13,000; the further exemption introduced by Ministerial Decree 234/2020 - and made structural by the Budget Law of 2020 (Law 178/2020) - provides that an additional percentage reduction is applied, varying from 10% to 30% and, for the a.y. 2021-22, the University fits into this intervention by applying an additional cascade reduction of 30%.

Please compare the following table in this respect:

Students in possession of the above-mentioned merit requirement and enrolled from the second year beyond the normal duration of the degree programme who belong to a family unit:

- whose ISEE is lower than or equal to € 13,000, pay an annual full tuition fee of 200,00 euros
- whose ISEE is between € 13,001 and € 30,000, pay an annual full tuition fee that cannot exceed 10.5% of the ISEE quota exceeding € 13,000, without prejudice to the minimum contribution of 200.00 euros.

ISEE-based progressive tuition fees (Table 4) applies to students not meeting the aforementioned exemption requirements of merit, enrolment or income, or not getting any economic benefit from the application of the maximum amounts set by law.

#### B. ISEE-BASED REDUCTIONS

The full tuition fee is calculated on the ISEE indicator (Table 4) and applies to students not meeting the merit and/or ISEE-based exemption granted by law.

The table shows that the range of the full tuition fee amount varies proportionally and according to the ISEE range provided for in the first column.

The regional tax for the right to education is also proportionally calculated on the ISEE as follows:

## 5. OTHER FEE-WAIVERS AND FEE-REDUCTIONS OPTIONS

A number of partial or full exemptions from tuition fees is available and listed below.

### A. FEE-WAIVERS RESERVED FOR STUDENTS ELIGIBLE FOR A SCHOLARSHIP

The following fee-waiver options are reserved for students ELIGIBLE for the regional scholarship for a.y. 2021/22 ([www.unipd.it/en/scholarships](http://www.unipd.it/en/scholarships)).

- Students enrolled in the first year of a degree programme who will earn at least 20 ECTS credits by 10/08/2022 will benefit from **full exemption**: the regional tax paid with the first instalment will be automatically refunded. No further instalments are due.
- Students enrolled in the first year of a degree programme who will earn at least 20 ECTS credits by 30/11/2022, rather than by 10/08/2022, can benefit from **partial exemption**: the regional tax paid with the first instalment will be automatically refunded, while 50% of the annual full tuition fee is to be paid by 30 September 2022.
- Students regularly enrolled in years subsequent to the first of a degree programme or enrolled in a PhD programme can benefit from **full exemption**: the first instalment, if paid upon enrolment, will be automatically refunded, except for stamp duty. No further instalments are due.
- Students enrolled in the first year beyond the regular duration of the degree programme (i.e. last semester) can benefit from **partial exemption**, which entails automatic refund of the first instalment of tuition fees including:
  - regional tax for the right to higher education;
  - 50% of the annual full tuition fee.No further instalments are due.

### B. FEE-WAIVERS RESERVED FOR INTERNATIONAL STUDENTS ENROLLING IN ENGLISH-TAUGHT DEGREE PROGRAMMES

The University of Padua offers up to 100 exemptions from the full tuition fee to deserving international students enrolling in an English-taught degree programme. They still need to pay an amount of € 189.00, which includes the stamp duty and the regional tax for the right to higher education.

To be eligible, under penalty of exclusion, candidates must:

1. not have an Italian citizenship (except for dual citizenship including Italian);
2. hold a qualification obtained abroad allowing admission to the Italian University system, namely a non-Italian upper secondary school certificate (for Bachelor's or Single cycle degrees applicants) or a non-Italian Bachelor's degree (for Master's degrees applicants);
3. apply for an English-taught degree programme of the University of Padua for A.Y. 2020/21.

In order to be admitted to the selection process, candidates are required to pre-enrol for the chosen English-taught degree programme and pay the pre-enrolment fee (€ 30.00), according to the procedures and deadlines set forth by the relevant calls for applications. There will be no separate application forms to fill out nor additional specific documents to submit. Exemptions will be awarded by the Teaching Committee of each degree programme to the most deserving international students, based on academic excellence in their field of study, quality, and results from their previous academic career.

### C. FEE REDUCTION FOR STUDENTS USING QUALIFICATION RECOGNITION SERVICE IN AGREEMENT WITH CIMEA

Students who use the qualification recognition service, under the agreement between the University and CIMEA, and subsequently finalise their enrolment are entitled to a reduction in the full tuition fee that may be due, up to a maximum amount equal to the cost incurred for the service.

#### D. FEE-WAIVERS RESERVED FOR STUDENTS WITH DISABILITIES

- Students with disabilities enrolled in degree or PhD programmes, or Specialisation schools, with a disability level between 66% and 100% officially recognised by NHS committees, or with a disability recognised as per article 3 of Law 104 of 5 February 1992, are **fully exempted** from the full tuition fee. They only need to pay the stamp duty.
- Students with disabilities enrolled in degree or PhD programmes, or Specialisation schools, with a disability level between 50% and 65%, officially recognised by NHS committees, and an ISEE up to € 28,000.00, are **partially exempted**. They need to pay a fixed annual fee of € 380.00, the regional tax and the stamp duty (such fee is already included in the first instalment for enrolments in years subsequent to the first, or is divided between the second and third instalment for enrolments in the first year).
- A **full exemption** from the full tuition fee, pursuant to art. 30 of Law 118/1971, is reserved for civilians amputees and civilians with disabilities, who have suffered from a reduction in work capacity by more than two thirds and whose families live in poor economic condition, as well as for children of beneficiaries of a disability pension, children orphaned by the war, civilians blind, people suffering from war-related or occupational injuries or disabilities and their children.

Applications for these exemptions must be submitted by notifying the University of the disability, using the student's personal area on Uniweb, and by handing in the certification to the Student Service Office (either in person in Via Portello 23 in Padova or by email to [inclusionestudenti@unipd.it](mailto:inclusionestudenti@unipd.it)).

The deadline for applications for such exemptions is the same as the deadline for Applications for Benefits, in section 2 of this call. The tuition fee will not be recalculated on certifications related to academic years already over.

The relevant forms are available at [www.unipd.it/accoglienza-prove-ingresso](http://www.unipd.it/accoglienza-prove-ingresso).

Certifications must be submitted only once and shall be considered valid for all their duration; reductions in tuition fee automatically apply to subsequent academic years (students need to submit new certifications as soon as possible to replace previous ones).

Applications for reduction in the regional tax must be submitted as per instructions in point 2 of this call.

#### E. INCOME-BASED EXEMPTION (UNIVERSITY NO TAX AREA)

Students with an ISEE equal to or lower than **€ 6,500** who **do not meet the merit requirement, set by the aforementioned exemption by law**, can benefit from partial exemption from the full tuition fee. Such exemption entails, in addition to the payment of the ISEE-based regional tax and the stamp duty, the payment of the annual fixed full tuition fee of € 380.00, which is already included in the first instalment for enrolments in years subsequent to the first, or divided between the second and third instalment for enrolments in the first year.

Applications for such exemptions must be submitted as per instructions in point 2 of this call for applications.

#### F. FEE-WAIVER RESERVED FOR IMPRISONED STUDENTS

Students in Triveneto's Penitentiaries (imprisoned, or serving sentences differently, or on probation), identified as such because meeting the criteria set forth by the Implementation and Management Committee provided for by the existing Convention between the Ministry of Justice and the University of Padua, are **fully exempted from the full tuition fee**. They only need to pay the stamp duty and the ISEE-based regional tax for the right to higher education.

Applications for reduction in the regional tax must be submitted as per instructions in point 2 of this call.

#### G. FEE-WAIVERS RESERVED FOR WORKING STUDENTS

Students with an annual gross income of at least **€ 3,500.00** earned in 2020 or in 2021 thanks to a fixed term or open-ended employment contract, or other self-employment jobs are entitled to **partial exemption from the full tuition fee**. This exemption applies to the second and third instalment and is determined as follows:

0 – 28,000	40%
28,000.01 – 50,000	25%
> 50,000	(no exemption)

The exemption is granted for a number of years equal to the normal duration of the degree programme + 3 years, starting from the year of first enrolment.

To apply for this exemption, students need to answer 'yes' to the relevant question in the **Application for benefits** in Uniweb and authorise the University to acquire their ISEE for the right to higher education, as set forth by point 2 of this call.

The Student Service Office may ask for documents proving the minimum income threshold even after exemption has been granted, while carrying out checks provided for by law.

#### H. FEE-WAIVERS RESERVED FOR STUDENTS FROM THE SAME HOUSEHOLD

Households with an ISEE up to 30,000.00 and more than one student enrolled in degree or PhD programmes, or Specialisation degrees at the University of Padua in academic year 2021/23 can benefit from a reduction in the full tuition fee by € 300.00, which is applied to the second and third instalment for each student enrolled in degree programmes and applying for reduction.

To apply for this exemption, students need to answer 'yes' to the relevant question in the **Application for benefits** in Uniweb and authorise the University to acquire their ISEE for the right to higher education, as set forth by point 2 of this call.

The Student Service Office may ask for documents proving the household composition and enrolment of one or more household members at the University of Padua in a.y. 2021/23 even after exemption is granted, while carrying out the check provided for by law.

#### I. FEE-WAIVERS RESERVED FOR PARENTS

Students enrolled in a Bachelor's, Master's and Single-cycle degree programmes are granted partial exemption from the full tuition fee for the academic year when their child is born. They need to pay a fixed annual fee of € 380.00 in addition to the regional tax and the stamp duty (the fee of € 380.00 is already included in the first instalment for enrolments in years subsequent to the first or divided between the second and third instalment for first year enrolments).

To apply for such exemption a self-certification of the birth certificate, stating maternity or paternity, or the family status certificate must be sent by email to: [benefici.studenti@unipd.it](mailto:benefici.studenti@unipd.it).

If both the mother and the father are enrolled at the University of Padua simultaneously, exemption may be applied for by only one of the parents.

#### J. MERIT-BASED FEE-WAIVERS RESERVED FOR NEWLY ENROLLED STUDENTS

Students enrolled in the first year:

- of Bachelor's and Single-cycle degree programmes with an upper secondary school final mark equal to 60/60 or 100/100;
  - of Master's degree programmes with a final graduation mark equal to 110/110 or 110/110 with honours;
- are granted **partial exemption** from the full tuition fee, which entails a reduction by € 200.00 automatically applied to the second and third instalment (students do not have to submit any application for it).

#### K. FEE-WAIVERS RESERVED FOR UNIVERSITY EMPLOYEES

Technical and administrative staff with an open-ended employment contract enrolling in a degree programme consistent with their job, or - only in case of first degree - a Bachelor's degree programme of interest to the activities carried out at the University, can benefit from **partial exemption**. They will need to pay the annual fixed tuition fee of € 380.00 in addition to the regional tax and the stamp duty (the fee of € 380.00 is already included in the first instalment for enrolments in years subsequent to the first or divided between the second and third instalment for first year enrolments).

Students who gain at least 30 ECTS credits by the end of academic year will be partially refunded (up to € 200).

Students may benefit from such exemptions for a maximum number of years which is double the normal duration of their degree programme.

If the budget for academic year cannot cover all of the applications, the exemption will be granted to employees according to a priority list. The criteria this priority list is based on are made available each year by the Technical and Administrative Staff Office (as per resolution of the BoD of 21/07/2008).

Applications for reduction in the regional tax must be submitted as per instructions in point 2 of this call.

#### L. FEE-WAIVERS RESERVED FOR PRISON OFFICERS

Thanks to the “University in jail” project, staff working at the “Due Palazzi” prison in Padua can benefit from partial exemption from the full tuition fee. In addition to the payment of the ISEE-based regional tax and the stamp duty, such exemption also entails the payment of the annual fixed full tuition fee of € 380.00, which is already included in the first instalment for enrolments in years subsequent to the first, or divided between the second and third instalment for first year enrolments. Applications for reduction in the regional tax must be submitted by confirming the Application for benefits in Uniweb and, therefore, authorising the University to acquire the ISEE for the right to higher education, as set forth by point 2 of this call.

#### M. FEE-WAIVERS RESERVED FOR PART-TIME STUDENTS

Students who choose to enrol part time must pay all three instalments each academic year. In addition to the first instalment, the amount due in the second and third instalment is 50% of the amount calculated on the ISEE, with a 10% increase in full tuition fee the student should have paid if they had enrolled full time.

Applications for part-time enrolment must be submitted no later than **30 November 2021** only by using the online procedure available at: [www.unipd.it/studiare-tempo-parziale](http://www.unipd.it/studiare-tempo-parziale).

The above deadline does not apply to master's degree students who finalise their enrolment after the deadline of 30 November; in such case the application must be submitted at the same time of the enrolment.

The list of degree programmes that admit part-time enrolment is available at [www.unipd.it/studiare-tempo-parziale](http://www.unipd.it/studiare-tempo-parziale).

To benefit from the reduction students must also meet one of the following requirements:

- They must have already entered into either an open-ended employment contract or a fixed term employment contract of at least six months' duration, even if not continuous, or be self-employed workers, with a **minimum annual gross income of € 6,500.00**. Their application must be completed by enclosing copy of the latest employee's tax certificate, issued to employees by their company (Certificazione Unica), or copy of the section on self-employment or business tax certificate of the latest version available.
- They must be **taking care of and providing assistance to non-self-sufficient relatives on a regular basis**, for age (children under the age of 3) or health reasons (parents, mother/father-in-law, children living in the same household, siblings, partner). The application must be submitted along with the certification of non-self-sufficiency or on health condition of the family member.
- They must suffer from a condition which does not affect learning abilities yet physically impairs or discourages them from a full-time activity. The application must be submitted along with a medical certificate.
- They must be simultaneously enrolled at Higher Education Institutions for Fine Arts, Music and Dance. The application must be submitted along with copy of enrolment at such institutions.

#### Please note that under part-time enrolment:

- students are bound to **two academic years** at the end of which, when renewing annual enrolment, they can apply for other two years of part-time enrolment by submitting the application form and the necessary documents once again;
- the **maximum number of ECTS credits** students can gain in the two-year period of part-time enrolment is **equal to 72**. Should students exceed the limit, the reductions will be revoked;
- if students complete the degree programme before two academic years have elapsed or exceeds the set threshold during the two-year period of part-time enrolment, they will be considered as full-time students, and the tuition fees already paid will be adjusted to a full annual tuition fee for full-time enrolment;
- only the tuition fee amount is affected (compulsory attendance is subject to academic regulations of each degree programme);
- incompatibility with other partial fee-waiver options and with participation in the competition for student collaborations (200 hours) exists.

#### N. FEE-WAIVERS FOR STUDENTS WITH REFUGEE STATUS

Students with refugee status or under subsidiary protection are **fully exempted from the annual full tuition fee**. They only need to pay the stamp duty and the regional tax for the right to higher education.

## 6. ADDITIONAL CHARGES FOR STUDENTS BEHIND WITH THEIR STUDIES

**Additional charges** will be applied to tuition fees for enrolled students falling behind with their studies. The tuition fee will be increased according to the ISEE entered into the system and the number of years of enrolment beyond the normal duration of the degree programme plus one, starting from the A.Y. of first enrolment, as per the following table:

Years beyond the standard duration of the degree programme	ISEE € 0 - € 150,000	ISEE > € 150,000
2 - 5	10%	40%
≥ 6	25%	80%

No additional charges are levied on students behind with their studies by one year, starting from the academic year of first enrolment in the university system.

If the Application for benefits in Uniweb is not submitted, the ISEE is equated with the maximum value. Years as part-time student are not included in the count.

In case of working students behind with their studies, increase percentages are halved.

Years of suspension are not included in the count to determine the overall number of years of enrolment which are taken into consideration when applying additional charges.

## 7. OTHER CHARGES AND LATE PAYMENT FEE

If instalments are paid after the expiration of the deadlines mentioned above, a late payment fee of **€ 21.00 for payments up to 15 days late** and of **€ 54.00 for payments 16 days late or longer** are charged.

The charge for first instalment late payment will be calculated and added to the second and third instalment; the charge for second and/or third instalment late payment will be calculated and added to the first instalment of the following academic year.

This rule does not apply to students of degree programmes prior to Italian MD 509/99 falling behind with their studies and students registering for graduation in December and finalising their enrolment to the new academic year later.

Students who make the payment late implicitly renounce to training activities until the payment is made.
