## 1. GENERAL INFORMATION AND ADMISSION REQUIREMENTS

This call is intended for **Italian, European Union, or equivalent candidates**. This category includes:

- citizens of any member state of the European Union;
- citizens of Iceland, Liechtenstein, Norway, Switzerland, and the Republic of San Marino;
- citizens with dual citizenship, one of which is Italian/European;
- citizens of non-EU countries residing in Italy and holding a valid residence permit that allows enrolment in university, in accordance with the current regulations on enrolment: <https://www.unipd.it/en/stays-over-90-days-study> ;
- candidates holding an Italian qualification granting university access, regardless of their citizenship.

Non-EU candidates residing abroad who do not fall under any of the categories described will participate in a separate selection. The relevant call is available at <https://www.unipd.it/avvisi-ammissione-lauree-triennali-ciclo-unico>.

### 1.1 Courses, venues, and available places

## 1.2 Admission requirements

To access the degree programme, candidates can take part in **two** selections.

To enter the degree programme, candidates must meet the conditions specified in the following three points:

1) hold an upper secondary school **certificate** obtained in Italy or abroad. In case of a foreign qualification recognised as eligible for entry to university education according to current legislation ([www.unipd.it/iscrizioni-studenti-internazionali](http://www.unipd.it/iscrizioni-studenti-internazionali)), specific requirements are assessed accordingly to the information available at the following page: <https://www.unipd.it/en/entry-title-requirements>. It is possible to be registered in the last year of upper secondary school with the prospect of obtaining the qualification in the 2024/25 school year. The qualification data must be updated by the mandatory deadlines ([point 2](#));

2) demonstrate an English language proficiency of at least **B2 level** (CEFR) by submitting a certificate **by 31 July 2025**, except in the specified cases of exemption. The list of accepted certificates, the relative minimum scores required and exemptions is available in [annex 2](#). The required documents must be submitted by the mandatory deadlines ([point 2](#))

3) take part in at least one of the two selection processes ([points 2.1, 2.2](#)):

- by taking a CISIA - Consortium of Inter-University Integrated Access Systems - **English TOLC-I** test ([point 3](#)) by the mandatory deadlines specified in the selection process they are taking part in. It is necessary to obtain scores higher than or equal to the threshold of **29 out of 50** set out in in the first selection process (sum of the Mathematics, Logic, Sciences, Reading Comprehension sections);

**and**

- **by pre-enrolling** by the mandatory deadlines set out for each selection process. Candidates must follow different admission procedures based on the country in which the school certification has been obtained. The order in which the pre-enrolment and TOLC test need to be completed is irrelevant for the purposes of entry, provided that both are completed by the specified deadlines;



### 1.3 Allocation of available places and criteria to decide on the admission ranking list

The **available places** are distributed between the two selection processes as follows:

**Only eligible candidates**, i.e. those who have **pre-enrolled**, who have taken an **English TOLC-I** test ([point 2](#)) by the prescribed deadlines and, solely for the first **selection** process, who have obtained a score higher than or equal to the **threshold**, are placed in the ranking list.

In the event that more than one **English TOLC-I** test has been taken, the English TOLC-I test with the **best score** out of those taken by the specified deadlines for the relevant selection process will be considered for inclusion in the ranking list.

The ranking lists for the selection processes referred to in [point 2](#) are drawn up in order of scores.

In the event of a **tied** score, in both selection processes, precedence is given to the candidate who:

1. scored higher in the Mathematics (1) section and sequentially in the Logic, (2) Reading Comprehension (3) and Sciences (4) sections;
2. in the event of a further tie, the youngest candidate will be preferred.

### 1.4 Career Shortening

It is possible to request the recognition of credits already earned in previous university careers in order to access the course with career shortening. The recognition is carried out by submitting a specific online request, as indicated on the page [www.unipd.it/riconoscimento-crediti-pregressi](http://www.unipd.it/riconoscimento-crediti-pregressi). Information on the procedures for accessing the course for those who have obtained a resolution with recognized activities is available in [annex 1](#) of this call.

## 2. SELECTION PROCESSES: DEADLINES AND TERMS TO BE MET

To participate in the selection processes, candidates must take the CISIA - Consortium of Inter-University Integrated Access Systems - English TOLC-I test; the structure of the test and the knowledge required (Syllabus) are available at <https://www.cisiaonline.it/area-tematica-english-tolc-ingegneria/structure-and-syllabus/>.

The procedure for booking the test are available at [point 3](#).

The following points contain the deadlines and procedures to be followed for each selection process.



## 2.1 First selection process

### 2.1.1 Deadlines and procedures

Candidates not yet in possession of the qualification can participate in the selection process with the obligation to obtain their qualification **by 31 July 2025**.

To participate in the first selection process and enrol, candidates need to:

1. **have taken at least an English TOLC-I test** ([point 3](#)) in the period from **1 January 2024** to **18 April 2025**
2. **apply and upload the required documents** from **7 March – to 18 April 2025**. Procedures differ based on the country in which the school qualification has been issued (Italy: [point 2.1.2](#), abroad: [point 2.1.2](#));
3. **submit the required language documentation** ([annex 2](#)). Procedures differ based on the country in which the school qualification has been issued (Italy: [point 2.1.2](#), or abroad: [point 2.1.2](#)) by **31 July 2025**;
4. **be admitted and accept the place**: the ranking list of those admitted<sup>2</sup> and of those that are eligible but not admitted<sup>3</sup> will be published on the dates and pages set out in [point 2.1.4](#).

### 2.1.2 Application and documentation upload – Candidates with a qualification obtained in Italy

#### Entry title

Enrolment is conditioned to the obtainment of the school qualification and the update of its data in the Uniweb portal. Any extensions to the given deadline (31 July 2025) must be directed to [immatricolazioni.studenti@unipd.it](mailto:immatricolazioni.studenti@unipd.it) no later than 31 July 2025.

#### Registration on the Uniweb portal

If candidates are logging into Uniweb for the first time, they must create a new user account at [www.uniweb.unipd.it](http://www.uniweb.unipd.it) by clicking on *Menu → Registration*.

At the end of the registration process, candidates will receive an email with a username and an activation code to log in to [uniweb.unipd.it/password/index.php/it/utenti/identifica/azione/a](http://uniweb.unipd.it/password/index.php/it/utenti/identifica/azione/a), where they will be asked to set up three security questions and a password. ## Pre-enrolment

Pre-enrolment must be submitted

**from 7 March 2025 to no later than 11:59 pm (local time - GMT+1) on 18 April 2025.**

To pre-enrol, candidates must log into [www.uniweb.unipd.it](http://www.uniweb.unipd.it) and click on *Educational offer* → *Pre-enrolment with a limited number of places* → *Course Type “Degree Programme”* → *Biology of human and environmental health – First selection*

The following documents must be submitted for pre-enrolment:

- a) for one's own personal data sheet:
  - copy of an identity document: ID Card for EU citizens or a passport for non-EU citizens
  - only for non-EU citizens residing in Italy: copy of residence permit
- b) for the assessment of curricular requirements:
  - if already held, certificate of English language proficiency of B2 level (CEFR) or higher, or documentation certifying that the candidate falls within the specified cases of exemption. The list of accepted certificates, the relative minimum scores required and exemptions is available at [annex 2](#).

Candidates who do not yet hold their **language certificate** at this time, may provisionally participate the selection process, and they are required to submit the language certificate **no later than 31 July 2025**. The procedures for submitting the certificate are disclosed at the same time as the publication of the ranking list.

## Acquisition of results

The English TOLC-I score is acquired automatically and is available in the Uniweb portal after the end of the pre-enrolment deadlines, before the merit list is published. The score is acquired through one's **tax identification number**, which must be identical on both the **Uniweb** portal ([point 4](#)) and the **CISIA** portal.

The final update of the TOLC test results is acquired automatically at the latest 3 working days after the closing of pre-enrolments: any reports of **non-acquisition** of results will be taken into account **after** this timeframe **and before** the publication of the ranking list for the selection process the candidate is taking part in.

### 2.1.3 Application and documentation upload – Candidates with a qualification obtained abroad

The application must be submitted by accessing the personal area of the portal at <https://apply.unipd.it>

**from 7 March 2025 to no later than 11:59 pm (local time - GMT+2) on 18 April 2025.**

Those who are not yet registered need to enter their email address at <https://apply.unipd.it/applicant/register>. A PIN code will be generated and they will receive a verification email at the specified address in order to complete their registration.

**N.B.:** the personal email address included in the apply.unipd.it portal is the communication channel that will be used to communicate deadlines and to provide instructions for access to the degree programme. Emails sent for this purpose count as an official communication.

Candidates can choose up to three degree programmes from the portal, listing them in order of preference. After selecting the degree programmes, click on “*Apply now*” and fill in all the required fields.

The documents to be uploaded for the application are as follows:

- a) for one's own personal data sheet:
  - copy of an identity document: ID Card for EU citizens or a passport for non-EU citizens
  - only for non-EU citizens residing in Italy: copy of residence permit
- b) for the assessment of curricular requirements:
  - upper secondary school certificate<sup>4</sup> (obtained after at least 12 years of schooling) or certificate of registration in the final year, with the relevant translation into Italian or English. If the certificate was obtained after a shorter period of schooling, the documents specified by the ministerial guidelines must also be uploaded: <https://www.universitaly.it/studenti-stranieri>
  - transcript of records (ToR), with the relevant translation into Italian or English;
- c) for applying to the selection:
  - English TOLC-I test results ([point 3](#))
- d) certificate of English language proficiency of **B2 level** (CEFR) or higher, or documentation certifying that the candidate falls within the specified cases of exemption. The list of accepted certificates, the relative minimum grades required and exemptions is available at <https://www.unipd.it/en/language-requirement-admission-degree-programmes>.

Candidates who do not yet hold their **language certificate** at this time, may provisionally participate the selection process, and they are required to submit the language certificate **no later than 31 July 2025**. The procedures for submitting the certificate are disclosed at the same time as the publication of the ranking list.

e) for completing the enrolment:

- authentication of the qualification or the CIMEA Statement of Verification are optional for the application, but are required **for the enrolment, and they must be submitted no later than 31 October 2025**.

The Admissions and Welcome Unit reserves the right to mandatorily request the CIMEA Statement of Comparability of the entry qualification if further verification of the qualification is deemed necessary.

Once **the required documents have been entered and payment has been completed**, the application must be submitted by clicking on the “**Submit**” button.

Admission is subject to verification of the declared qualifications, the awarding of the qualification, if not yet held, and, in the case of a qualification awarded abroad, the submission of the documents specified on [www.unipd.it/iscrizioni-studenti-internazionali](http://www.unipd.it/iscrizioni-studenti-internazionali).

Candidates who fail to meet the deadlines for obtaining and submitting the required qualifications ([point 1.2](#)) will lose their place in the ranking list.

Candidates who do not yet hold their **language certificate** or **entry qualification** at the time of assignment of a place on the ranking list, may provisionally accept the place that they have successfully gained, and they are required to update their entry qualification data and submit the language certificate **no later than 31 July 2025**. The procedures for updating the qualification details and submitting the certificate are disclosed at the same time as the publication of the ranking list.

## 2.2 Second Selection Process

### 2.2.1 Deadlines and procedures

Candidates who were not admitted or were ineligible in the first selection process may also participate in the second selection process, but they will need to **pre-enrol again**.

The number of **places available** in the second selection process (see table in [point 1.3](#)) will be published on **15/07/2024** at [www.unipd.it/ammissioni-sc-human](http://www.unipd.it/ammissioni-sc-human)

To participate in the second selection process and enrol, candidates need to:

- 1) **have taken at least an English TOLC-I test** ([point 3](#)) in the period from **1 January 2024** to **6 September 2025**. A minimum score is not required in this selection process;
- 2) **apply and upload the required documents** ([points 2.2.2, 2.2.3](#)) from **15 July (3 pm) to noon on 6 September 2025**. After 6 September the **best English TOLC-I score out of those taken by the specified deadlines** for the relevant selection process, will be considered for inclusion in the ranking list.
- 3) **submit the required language documentation** ([annex 2](#)) in the “Valutazione titoli” pre-enrolment section, **by 30 September**;
- 4) **be admitted and accept the place**: the ranking list of those admitted<sup>5</sup> and of those that are eligible but not admitted<sup>6</sup> will be published on the dates and pages set out in [point 2.2.4](#). The publication shall count as an official communication to the interested parties and also contain the indication of any assigned additional learning requirements (OFA), ([point 5.3](#)).

### 3. ENGLISH TOLC-I TEST: TAKING THE TEST

The English TOLC-I test is the test required for admission to the Biology of Human and Environmental Health degree programme.

It is delivered online on a platform provided by CISIA - Consortium of Inter-University Integrated Access Systems, a consortium of Italian universities.

#### 3.1 Validity of the TOLC and acquisition of results

To be valid for participation in the selection processes, the English TOLC-I test must:



- a) be taken **from 1 January 2024 and by the deadlines specified in the selection process the candidate is taking part in** ([points 2.1, 2.2](#));
- b) have a score higher than or equal to the threshold for participating in the first selection process ([point 2.1](#)).

**Attenzione:** simply taking the English TOLC-I test is not a sufficient condition for admission to the degree programme; candidates need to pre-enrol for the chosen selection process, as set out in [point 1.2](#).

A TOLC test of the same type can be taken at the most once per calendar month, including from abroad. Candidates can select the “Padua” venue to take the test in a virtual classroom (TOLC@CASA) or in person in a real classroom (TOLC at the University) managed by the University of Padua.

The test **is valid whether it is taken in the “@casa” mode or at the University**, at any of the consortium universities included [in the list of participating venues on the CISIA site](#).

Prospective students can both take part in multiple selection processes by taking just one English TOLC-I test and take part in one or more selection processes by taking multiple English TOLC-I tests. In the event that more than one English TOLC-I test has been taken, the English TOLC-I test with the **best score out of those taken by the specified deadlines** for the relevant selection process, will be considered for inclusion in the ranking list ([points 2.1 - 2.2](#)).

The score is acquired through one’s **tax identification number**, which must be identical on both the **Uniweb** portal ([point 4.1](#)) and the **CISIA** portal.

The final update of the TOLC test results is acquired automatically at the latest 3 working days after the closing of pre-enrolments: any reports of **non-acquisition** of results will be taken into account **after** this timeframe **and before** the publication of the ranking list for the selection process the candidate is taking part in.

The TOLC test is delivered via the platform provided by CISIA - Consortium of Inter-University Integrated Access Systems. ### 3.3 Request for a personalised test for candidates with a disability, impairment, or SLD diagnosis

Candidates with a disability, impairment, or specific learning disabilities (SLD), pursuant to Article 16 of Legge (Law) no. 104/1992 and Legge (Law) no. 170/2010, may, within the test registration procedure on the CISIA - Consortium of Inter-University Integrated Access Systems portal (point 3.2) request an admission test with additional time and/or customised support, by attaching the following documentation:

- **civil invalidity certificate and/or a certificate** pursuant to Legge (Law) no. 104 of 1992 issued by the medical committee for the relevant area, proving the type of disability (NO OMISSIONS) and, where envisaged, the recognised percentage of invalidity;
- **certificate of SLD diagnosis** issued no more than 3 years previously, if prior to the candidate's eighteenth birthday, or if subsequent to the candidate's eighteenth birthday, by state local health facilities or entities and professionals accredited with the regional health service. Where not already specified in the diagnosis, ask the accredited private facility for their accreditation code/no. In accordance with the provisions of the "Guidelines on Specific Learning Disorders" annexed to D.M. (Italian Ministerial Decree) no. 5669 of 12 July 2011, candidates with SLDs are granted additional time equal to a maximum of 30 per cent more than that defined for the admission test.

Candidates with SLDs may request additional time and/or customised support with the medical certification they possess, even if it has expired. The new documentation, updated for the cycle of university studies, must be sent to [inclusione.studenti@unipd.it](mailto:inclusione.studenti@unipd.it) by no later than 30 September 2025.

**Personalised Learning Plans (PLP) and diagnoses of SLDs issued before the last level of education (upper secondary education) and/or by non-accredited individuals or entities are not accepted under any circumstances.**

- **valid identity or identification document.**

Candidates with disabilities or specific learning disabilities (SLD) from EU and non-EU countries residing abroad who intend to use personalised support must submit the legalised certification,

## ANNEX 1 - RECOGNITION OF PRIOR CREDITS FOR CAREER SHORTENING

### 1. Recognition of previous educational credits

For recognition of the educational credits you have already acquired and to have your university career shortened, you need to submit a prior credit assessment application (roughly between June and the first half of July). The Assessment Committee prepares a resolution containing:

- the list of educational activities/recognised credits and/or integrations.
- proposed year of admission.

Candidates who are proposed for admission in the **first year** must take part in the selection processes as indicated in [point 1.2](#), without any difference from those who have not applied for credit recognition.
