| Abstract del progetto / Abstract | This Blended intensive Program (BIP) is organised by the <u>Digital Constitutionalism Network</u> (DCN) and offers students an opportunity to come together, both virtually and in person, to discuss issues |

pertaining to digital developments and related global policy development processes. This BIP is the development of a teaching partnership that the DCN has promoted since 2019. The 2026 BIP is dedicated to exploring the intersections of Digital Futures and Sustainable Freedoms through the lenses of digital constitutionalism. The BIP theme highlights the paradoxical nature of digital innovation, equally generating opportunities and risks for the environment. It sheds light on the potential of digital technologies by enabling democratic participation and enhancing transparency while its environmental and social implications risks compromising the very freedoms it aims to promote. It aims at providing students with the theoretical, analytical and methodological tools to make sense of the values and principles that (should) guide regulatory arrangements for the digital age, while addressing actors' interactions and power limitations in the same context. The 2026 BIP consists of two components - one online and one in-person - offering an interdisciplinary exploration of the evolving legal, political and societal challenges posed by the digital transformation. During the virtual preparatory phase, students will be introduced to foundational concepts in digital constitutionalism, digital innovation and sustainable implications of technological progress, guided by leading scholars in these fields. The in-person component begins with the students' engagement in an intensive program of design/future thinking exercises and expert inputs. Throughout various working phases, the students develop policy briefs on a relevant issue at the intersection of digital constitutionalism, digital innovation and sustainability. Further, they participate in the 10th GIG-ARTS Conference, themed "Digital Futures, Sustainable Freedoms: Rights, Responsibilities and Governance". This allows them to exchange with academics and practitioners on their ideas for our digital futures and gain invaluable feedback on their draft policy briefs. Following the conference, in the second virtual phase, students discuss the final versions of their policy briefs and explore opportunities to contribute to real-world policy processes, by taking part in international policy arenas initiatives such as the Internet Governance Forum (IGF).
