

# PSYCHOLOGICAL SCIENCE TECHNIQUES AND METHODS IN PSYCHOLOGICAL SCIENCE SELECTION FOR NON-EU CANDIDATES RESIDING ABROAD WITH A FOREIGN QUALIFICATION

## INFORMATION CONCERNING THE ENGLISH-PSY ENTRY TEST 26th March 2025

The entry test will take place on March 26th at 9.00 a.m. or at 2.00 p.m., CET.

Based on the timezones, candidates will be split in the two test rounds (9 a.m. or 2 p.m.) and will receive an e-mail with the time given to show up for the test from the no reply e-mail address <a href="mailto:register@cisiaonline.it">register@cisiaonline.it</a>. Please note that any mail sent to that address will not receive an answer.

The given test round will not be changed for any reason, therefore candidates will not be moved to one or another of the two rounds.

In order to take the test, candidates need to read and follow the guidelines provided by CISIA.

Candidates will **receive two automatic e-mails** from <u>register@cisiaonline.it</u> by March 25<sup>th</sup> with all details concerning the username and password to connect to the test.

The requirements concerning the **devices and minimum technical specifications** required to sit the test are available at <a href="https://www.unipd.it/ammissioni-bps-temps">https://www.unipd.it/ammissioni-bps-temps</a>.

#### Please note that the test may be invalidated for the following reasons:

- If a person enters the room after the candidate has been validated (i.e. after the candidate has shown the room, the desk, the sheets of paper and has been enabled to take the test);
- If the candidate speaks to another person after the validation and during the test;
- If the room chosen by the candidate to take the test is an open space, with more than two doors (e.g. if the room has tents instead of doors, thus giving the chance to any unauthorised people to enter the room, or if the is too big for the invigilators to see it in its entirety for the whole duration of the test). No public spaces will be accepted to take the test (e.g. offices with exposed glass):
- If the Zoom or CISIA connection is lost for more than 5 minutes continuously, or 10 minutes in total (for instance, the test is invalidated if the candidate leaves the Zoom meeting three times for 4 minutes each);
- If the candidate gets up without authorisation given by the invigilators at any time;
- If the candidate mutes the device or disconnects the video without authorisation given by the invigilators at any time;
- If the candidate uses any unauthorised device during the test;
- If the candidate uses any book, sheet of paper or any physical support with notes on it besides the blank sheets of paper checked by the invigilators during the validation;
- If the candidate leaves the fullscreen mode and opens any browser tab at any time;
- If the candidate does not follow the instructions given by the invigilators.

#### Please note that:

- the meeting is recorded, therefore any violation of the aforementioned regulations can cause the invalidation of the test DURING or AFTER the test has been taken;
- neither the VMWare Horizon Software, nor the Safe Exam Browser (SEB) will be used in the English-PSY entry test;
- -the test will be only held on March 26<sup>th</sup> with a single attempt available. The test will not be rescheduled;
- -the rules to follow are explained at paragraphs 4.2, 5, 6, 7 and 8 of the CISIA regulations.

### Candidates who will not be able to have a stable internet connection and/or will not set up the room for the test as required will be excluded from the test.




Fig 1. How to set up the room
