



**ADDENDUM TO THE MoU  
BETWEEN  
THE UNIVERSITY OF PADOVA – DEPARTMENT OF XXX  
AND  
THE UNIVERSITY OF XXXXXXXXXXXX – DEPARTMENT OF XXX  
ACADEMIC YEARS 20\_\_ – 20\_\_**

On the basis of the Memorandum of Understanding signed on xxx, the University of Padova (Italy) and the University of xxx (xxx), agree to implement and finance the mutual exchange of academic staff, researchers, technical-administrative staff and students (at bachelor's, master's and doctoral level) [and/or any other academic activities to be specified in the following article no. 1.2].

Article I.

1- Mobility

For each of the academic years of validity of this Addendum, the Parties agree to exchange a max. no. of x guests (x professors and x students) coming from each of the two Institutions; the max. duration of stay for each guest is established in the no. of x months per professor and the no. of x months per student.

The sending University shall select its own exchange participants, whose selection will have to be approved by the hosting University; the duration and the starting date of the visit shall be agreed by the Parties.

The participants' names, study/academic plan and arrival date shall be communicated to the hosting University by post, e-mail or fax at least two months before the starting date of the visit; the hosting University shall communicate its being available to host the selected guests within one month upon receipt of the information.

The hosting University shall not be considered responsible for the unfavourable effects arising from the delay of the communication or for any other inconvenience due to the sending University.

2 - Other activities

Article II

The Parties agree that round-trip travel expenses shall be covered by the sending University [and/or by other funds to be specified] and board and accommodation expenses shall be covered by the hosting University [and/or by other funds to be specified].

Students shall furthermore be exempted from the payment of tuition fees at the hosting University.

The Department of XXX of the University of Padova shall cover board and accommodation expenses incurred by the guests coming from the University of XXX with its own funds and up to a maximum of xxx Euro per month for each guest.

This Addendum, which will have to be coherent with the rules of the connected Memorandum of Understanding, shall be effective as of the latest signature date below and shall remain in force for a period of x years following this date, unless written notice is given by either Party; it shall in any case not remain in force after the expiration date of the connected Memorandum of Understanding. The notice shall take effect three months after the date of notification to the other Party. Nevertheless, the activities in progress in the framework of this Addendum shall not be compromised by the notice and shall be normally concluded.

This Addendum is drafted in two versions, in Italian and in English, both versions being legally binding. Each Party shall keep one original copy in each of the two versions.
