

APPLICATION FORM FOR CERTIFICATES

WARNING: art. 15 law no. 183/2011 declares that for public and private bodies delivering public services, you need self-certifications instead. You can use certificates when dealing with private bodies and institutes abroad.

- 1. Fill in the application form and specify for what reason you need the certificate. For certificates on stamped paper you need a revenue stamp (amount: € 16,00 per revenue stamp due).

3) If you need a revenue stamp you must pay € 16,00 through the PagoPa portal, following these instructions:

Go to the link: https://unipd.pagoatenei.cineca.it

Click on Voluntary Payment and fill in with the necessary data for the payment. Select 'DIDA02 - Stamp duty - Certificates' as Payment reason (amount: € 16,00 per revenue stamp due) and in the field reason digit "Imposta di bollo per rilascio certificato a favore di (insert surname and name)".

Click on Start online payment.

Download the payment receipt from the same portal and enclose it to the application form (with the copy of your ID card).
