## 1. GENERAL INFORMATION

Prospective students can now apply for admission to the first year of the Master's degrees with unlimited access and admission requirements at the Scuola di Scienze Umane, Sociali e del Patrimonio Culturale <sup>2</sup> for academic year 2024/25.

Degree programmes normally run for 2 years and a Master's Degree is awarded at the end of the chosen Degree Programme.

## 1.2 Admission requirements

To be admitted, candidates<sup>3</sup> must:

1. have obtained a Bachelor's degree, a single-cycle degree, a three-year university bachelor's diploma or another qualification obtained in Italy and recognised as suitable under current legislation, **by 31 October 2024** or, during the year, **by 31 January 2025**;
2. be in possession of the specific minimum curricular requirements and knowledge, competencies, and abilities, verified as set out in [appendix 1](#). Prospective students are advised to read the full description in Article 2, paragraph 1, of the relevant Syllabus Regulations. The full information sheet on the degree programme and the Syllabus Regulations is available at [didattica.unipd.it](http://didattica.unipd.it), by selecting the degree programme of interest;
3. **pre-enrol** by the set deadlines ([point 2](#));
4. submit an application for the **assessment of the minimum curricular requirements** by the set deadlines ([point 3](#));

5. **enrol**, submit an application for a change of course or incoming transfer **by 12 noon on 31 October 2024** ([point 4.1](#)).

An additional enrolment period is provided for during the year, **from 12 noon on 31 October 2024 to 12 noon on 15 February 2025** ([point 4.2](#)).

## 2. REGISTRATION AND PRE-ENROLMENT ON THE UNIWEB PORTAL

### 2.1 Registration on the Uniweb portal

If you are logging into Uniweb for the first time, you must create a new user account at [www.uniweb.unipd.it](http://www.uniweb.unipd.it) by clicking *Menu → Registration*.

At the end of the registration process, candidates will receive an email with a username and an activation code to log in to [uniweb.unipd.it/password/index.php/it/utenti/identifica/azione/a](http://uniweb.unipd.it/password/index.php/it/utenti/identifica/azione/a), where they will be asked to set up three security questions and a password. With the username obtained and the password set, candidates can log in to their personal area.

Students can also register with the [www.uniweb.unipd.it](http://www.uniweb.unipd.it) portal using SPID credentials by clicking on *Menu → Registration with SPID*.

In the event of problems with logging in, please contact the University Call Centre ([www.unipd.it/callcentre](http://www.unipd.it/callcentre)).

**N.B.:** the personal email address included in the Uniweb profile is the communication channel that will be used to communicate deadlines and to provide instructions for access to the degree programme. Emails sent for this purpose count as an official communication.

### 2.2 Online pre-enrolment

To pre-enrol, you must:

1. log in with your credentials at [www.uniweb.unipd.it](http://www.uniweb.unipd.it), click on *Educational Offer → Pre-enrolment with unlimited access → Type "Master's Degree Programme"* and select the degree programme of interest ([point 1.1](#)).
2. enter the degree qualification to be used to access the degree programme, if not already on the system.

**Students enrolled at the University of Padua** who are about to graduate can only complete pre-enrolment after submitting their application for the degree award online. If this application has not been submitted yet, in order to proceed, candidates will need to write to [immatricolazioni.studenti@unipd.it](mailto:immatricolazioni.studenti@unipd.it) to explain their situation, attaching a valid identity document.

3. at the same time, pay the pre-enrolment fee of 30.00 euro via the PagoPA procedure (instructions on [www.unipd.it/pago-pa](http://www.unipd.it/pago-pa)).

Prospective students can apply for pre-enrolment for access to one or more degree programmes among those indicated in this call. For each pre-enrolment, to be submitted by the deadlines set out in points [2.2.1](#) and [2.2.2](#), you need to follow the instructions in the three given points and submit the application for the assessment of minimum curricular requirements ([point 3](#)).

**For the Master's Degree programme in Scienze delle Religioni, run jointly with the Ca' Foscari University of Venice, the deadline for this pre-enrolment window is set at 23 August 2024, at 12 noon.**

### **2.2.1 Deadlines – candidates graduating by 31 October 2024**

In order to be able to submit the application for enrolment, change of course or incoming transfer by 31 October 2024 for all the degree programmes in this call ([point 4.1](#)), the application for pre-enrolment must be completed online, through the Uniweb portal, as set out in [point 2.2](#).

**from 3 pm on 16 July to 12 noon on 30 September 2024.**

### **2.2.2 Deadlines – Pre-enrolment during the year**

In order to be able to submit the application for enrolment during the year ([point 4.2](#)), there will be an additional time window for pre-enrolment online ([point 2.2](#)):

**from 12 noon on 31 October 2024 to 12 noon on 31 January 2025**

**N.B.:** candidates who use this time window for pre-enrolment will only be able to gain entry to the degree programmes through standard enrolment (**course change** and **incoming transfer** procedures are only available until **12 noon on 31 October 2024**).

## **3. ASSESSING THE MINIMUM CURRICULAR REQUIREMENTS**

To be admitted to your chosen degree programme, you need to be in possession of the specific minimum curricular requirements and knowledge, competencies, and abilities, verified as set out for each degree programme ([appendix 1](#)).

Anyone intending to apply for entry to more than one degree programme must submit an application for the assessment of the minimum curricular requirements (in addition to the related pre-enrolment) for each degree programme of interest.



### 3.1 Procedure and deadlines – candidates graduating by 31 October 2024

In order to be able to take advantage of the first window for enrolment ([point 4.1](#)), applications for the assessment of the minimum curricular requirements must be submitted and confirmed:

**by 12 noon on 31 October 2024.**

## 4. ENROLMENT, CHANGE OF COURSE, AND TRANSFER FROM ANOTHER UNIVERSITY

### 4.1 Procedure and deadlines – candidates graduating by 31 October 2024

To enrol, change course, or transfer from another University for all the degree programmes in this call, candidates must:

- have submitted an application for pre-enrolment ([point 2](#)) **by 30 September 2024**;
- have checked the registration of the entry qualification details in the Uniweb personal area. Registration will take place automatically for graduates from the University of Padua; graduates from other universities will instead have to update their degree details in the Uniweb personal area in the *Educational Offer* → *Qualifications* section;
- have submitted an application for the assessment of the minimum curricular requirements **by 31 October 2024** ([point 3](#)) and have obtained the outcome “eligible” (visible within pre-enrolment in each user’s personal area in Uniweb).

Applications for enrolment or transfer from another university must be submitted  
**from 3 pm on 16 July to 12 noon on 31 October 2024.**

Applications for changing course must be submitted:

**from 3 pm on 2 September to 12 noon on 31 October 2024.**

## 5. RECOGNITION OF CREDITS TO SHORTEN THE UNIVERSITY CAREER

Candidates may apply to have the training activities and exams they have obtained from master's degree programmes (including those obtained abroad) - such as single course units or previous university careers - recognised so as not to have to repeat them during their degree programme.

However, in order to access the degree programme by means of career shortening, it is necessary to fulfil the requirements and complete all the procedures (including methods and deadlines) as set out in [point 1.2](#) of this call.

Instructions for submitting the application for credit recognition and the period of opening of the procedure will be announced on 16 July 2024 in the following document: [www.unipd.it/node/87721](http://www.unipd.it/node/87721). The university educational credits necessary to achieve the minimum curricular requirements, or those included in the qualification used for admission to the degree programme, **will not be considered** to shorten the university career.

The appointed teaching committee will issue a credit recognition resolution containing the list of recognised educational activities/credits and the proposed year of admission. After having obtained suitability as regards curricular requirements, candidates can proceed with enrolment, course changes, or incoming transfers **to the first year of the degree programme** as set out in [point 4](#), even if they do not yet have the credit recognition resolution.

Validation/recognition and any updates during the year (for those who will obtain admission to the second year in their credit recognition resolution) will be added to the online student record book by the relevant Back Office by the first exam session scheduled for the academic year 2024/25, without the need for further procedures or requests.
