## 1. GENERAL INFORMATION

Prospective students can now apply for admission to the first year of the Master's Degree Programmes with unlimited access and admission requirements at the Scuola di Scienze umane, sociali e del patrimonio culturale<sup>2</sup> for academic year 2025/26.

Please note that in addition to the degree programmes referred to in this call for admission, the Scuola di Scienze Umane, Sociali e del Patrimonio Culturale also provides the international master's degree program **Filologia Moderna - Francesistica e Italianistica** to which students can gain access following special selection. It is possible to apply for recognition of credits already acquired in previous university careers in order to enter the course with career shortening. Information on this is available in [point 5](#) of this notice.

## 1.2 Admission requirements

To be admitted, candidates must:

1. have obtained a Bachelor's degree, a single-cycle Master's degree, a three-year university bachelor's diploma or another qualification obtained in Italy and recognised as suitable under current legislation, **by 31 October 2025** or, for degree programmes that allow enrolment during the year<sup>3</sup>, **by 31 January 2026**.

Candidates with a foreign qualification must follow the procedures specified at <https://www.unipd.it/en/how-apply>

2. be in possession of the specific minimum curricular requirements and knowledge, competencies, and abilities, verified as set out in [annex 1](#).
3. **pre-enrol** by the set deadlines ([point 2](#));
4. submit an application for the **assessment of the minimum curricular requirements** by the set deadlines ([point 3](#));
5. **enrol**, submit an application for **a change of course or incoming transfer** by the set deadlines ([point 4](#)).

## 2. REGISTRATION AND PRE-ENROLMENT ON THE UNIWEB PORTAL

### 2.1 Registration on the Uniweb portal

If you are logging into Uniweb for the first time, you must create a new user account at [www.uniweb.unipd.it](https://www.uniweb.unipd.it) by clicking *Menu → Registration*.

At the end of the registration process, candidates will receive an email with a username and an activation code to log in to [uniweb.unipd.it/password/index.php/it/utenti/identifica/azione/a](https://uniweb.unipd.it/password/index.php/it/utenti/identifica/azione/a), where they will be asked to set up three security questions and a password. With the username obtained and the password set, candidates can log in to their personal area.

Students can also register with the [www.uniweb.unipd.it](https://www.uniweb.unipd.it) portal using SPID credentials by clicking on *Menu → Registration with SPID*.

## 2.2 Online pre-enrolment

To pre-enrol, you must:

1. log in with your credentials at [www.uniweb.unipd.it](http://www.uniweb.unipd.it), click on *Home* → *Evaluation test* → *Pre-enrolment for unlimited places* → *Master's Degree Course* and select the degree programme of interest ([point 1.1](#)).
2. enter the degree qualification to be used to access the degree programme, if not already on the system. **Students enrolled at the University of Padua** who are about to graduate can only complete the pre-enrolment after submitting their application for the degree award online. If this application has not been submitted yet, in order to proceed, you will need to make your situation known to [immatricolazioni.studenti@unipd.it](mailto:immatricolazioni.studenti@unipd.it), attaching an identity document;
3. at the same time, pay the pre-enrolment fee of 30.00 euro via the PagoPA procedure (instructions on <https://www.unipd.it/en/studying-padua/funding-and-fees/key-documents/pagopa> ).

Prospective students can apply for pre-enrolment for access to one or more degree programmes among those indicated in this call. For each pre-enrolment, to be submitted by the deadlines set out in points [2.2.1](#) and [2.2.2](#), you need to follow the instructions in the three given points and submit the application for the assessment of minimum curricular requirements ([point 3](#)).

### 2.2.1 Deadlines – candidates graduating by 31 October 2025

In order to be able to submit the application for enrolment, change of course or incoming transfer by 31 October 2025 for all the degree programmes in this call ([point 4.1](#)), the application for pre-enrolment must be completed online, through the Uniweb portal, as set out in [point 2.2](#).

**from 3 pm on 1 August to 12 noon on 30 September 2025.**

In order to be able to submit the application for enrolment during the year ([point 4.2](#)), there will be an additional time window for pre-enrolment online ([point 2.2](#)):

**from 12 noon on 31 October 2025 to 12 noon on 30 January 2026**

**N.B.:** candidates who use this time window for pre-enrolment will only be able to gain entry to the degree programmes through standard enrolment (**course change** and **incoming transfer** procedures are only available until **12 noon on 31 October 2025**).

### 3. KNOWLEDGE REQUIRED FOR ACCESS

To be admitted to your chosen degree programme, you need to be in possession of the specific minimum curricular requirements and knowledge, competencies, and abilities, verified as set out for each degree programme through the **minimum curricular requirements application** ([annex 1](#)). Anyone intending to apply for entry to more than one degree programme must submit an application for the assessment of the minimum curricular requirements (in addition to the related pre-enrolment) for each degree programme of interest.

#### 3.1 Procedure and deadlines – candidates graduating by 31 October 2025

In order to be able to take advantage of the first window for enrolment ([point 4.1](#)), applications for the assessment of the minimum curricular requirements must be submitted and confirmed:

**by 12 noon on 31 October 2025.**

## 4. ENROLMENT, CHANGE OF COURSE, AND TRANSFER FROM ANOTHER UNIVERSITY

### 4.1 Procedure and deadlines – candidates graduating by 31 October 2025

To enrol, change course, or transfer from another University for all the degree programmes in this call, candidates must:

- have submitted an application for pre-enrolment ([point 2](#)) **by 30 September 2025**;
- have checked the **registration of the entry qualification details** in the Uniweb personal area. Registration will take place automatically for graduates from the University of Padua; graduates from other universities will instead have to update their degree details in the Uniweb personal area in the *Home* → *Qualifications* section;
- have submitted an application for the assessment of the minimum curricular requirements **by 31 October 2025** ([point 3](#)) and have obtained the outcome “eligible” (“idoneo”) - visible within pre-enrolment in each user’s personal area in Uniweb).

Applications for enrolment or transfer from another university must be submitted  
**from 3 pm on 1 August to 12 noon on 31 October 2025.**

Applications for changing course must be submitted:

**from 3 pm on 2 September to 12 noon on 31 October 2025.**

The qualification must be awarded by 30 January 2026;
- have submitted an application for the assessment of the minimum curricular requirements by 31 January 2026 ([point 3](#)) and have obtained the outcome “eligible” (“idoneo”) - visible within pre-enrolment in each user's personal area in Uniweb.

In the enrolment period during the year, candidates can only submit an application for enrolment (they cannot submit applications to change course or transfer from another university):

**from 12 noon on 31 October 2025 to 12 noon on 16 February 2026**
