South Korea's Personal Information Protection Commission said the DeepSeek app became unavailable on Apple's App Store and Google Play on Saturday evening. It came after several South Korean government agencies banned their employees from downloading the chatbot to their work devices.

However, the company had previously come out strongly against this kind of data collection, saying in a 2019 blog that fingerprinting "subverts user choice and is wrong."

the guarantees poorer countries are given that they will have access to treatments and vaccines against a future pandemic disease, in exchange for providing samples and data to develop therapies.

Among primary school-age children between five and 12, 45% had a problem with their sleep pattern, including difficulty getting to sleep, waking overnight or waking in the morning, compared with 37% of teenagers between 13 and 17.

Climate change is also hindering poverty reduction, and disasters result in millions of households becoming poor or remaining trapped in poverty.

Except transportation, emissions from all major sectors have rebounded since the pandemic and now exceed 2019 levels. Governments plan to produce around 110 per cent more fossil fuels by 2030 than would be consistent with limiting warming to 1.5°C.

Extreme weather events, including heatwaves, major floods, droughts, wildfires and tropical cyclones, have disrupted the lives of millions of people and caused billions of dollars in economic losses. As of June 2024, a WMO climate update underscored an 80 per cent likelihood of at least one year temporarily exceeding 1.5°C from 2024 to 2028. In 2015, the probability for such a temperature spike was near zero.
