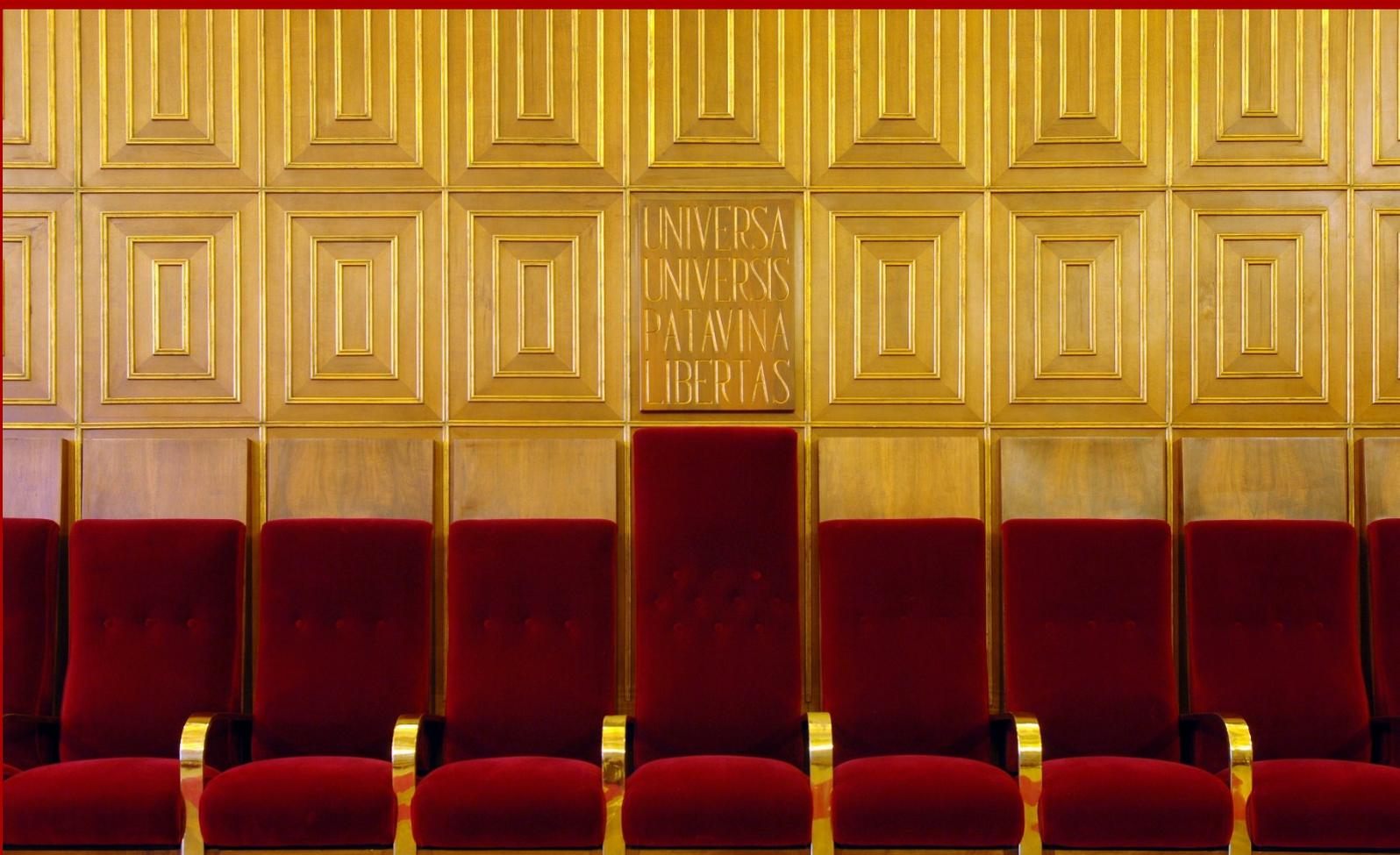

### 1.2 Admission requirements

To access the courses referred to in this call, candidates must:

1. Be in possession of a **first-level university qualification** (bachelor's degree, single-cycle master's degree, university diploma or equivalent) **obtained in Italy** and recognized as suitable according to current legislation. The qualification must have been obtained **by 30 October 2026** or, for courses with a full access period<sup>2</sup>, **by 29 January 2027**.

2. be in possession of the **minimum curricular requirements** and **personal preparation** required for each course as reported in [Annex 1](#).

4. submit the application for **assessment of the requirements** following the procedures and deadlines set out in [point 3](#);
5. submit an application for **enrolment, change of course or transfer in** accordance with the procedures and deadlines set out in [point 4](#).

### 2.3 Procedure: registration on the Uniweb portal and pre-enrolment application

**Only if you access Uniweb for the first time** is it necessary to create a new account; otherwise you can move on to the next point, "2. Pre-enrolment application".

#### 1. Registration on the Uniweb portal

To create a new account, you need to access the page [www.uniweb.unipd.it](http://www.uniweb.unipd.it) and click *Menu > Registration*.



At the end of the registration, you will receive an e-mail username and activation code with which to access the [uniweb.unipd.it/password/index.php/it/utenti/identifica/azione/a](http://uniweb.unipd.it/password/index.php/it/utenti/identifica/azione/a) page, where you will be asked to set three security questions and a password. With the username obtained and the password set, you can access your reserved area.

Registration on the [www.uniweb.unipd.it](http://www.uniweb.unipd.it) portal can also be done using the SPID credentials, by clicking on the *Menu > Registration with SPID*.

### 3.3 Procedure: Submit the application for assessment of requirements

To access the chosen course, it is necessary to be in possession of specific minimum curricular requirements and adequate personal preparation, as required by the teaching regulations of each course of study. The complete sheet of each course is available in [Annex 1](#).

This knowledge is verified through the submission of a specific application for assessment of the requirements.

If you intend to compete for access to more than one course, you must submit an application for assessment of the requirements (in addition to the related pre-enrolment) for each of the courses of your interest.

- from 12:00 noon on 15 July and **by 30 October 2026** (full day).

The application for **incoming transfer** must be submitted:

- from 12:00 noon on 15 July and **by 30 October 2026** (full day).

The application for **change degree programme** must be submitted:

- from 12:00 noon on 1 September and **by 30 October 2026** (full day).

Registration takes place automatically for graduates from the University of Padua; graduates from other universities must update their graduation data in the Uniweb reserved area in the *Home > Qualifications* section by 29 January 2027.

The application for **incoming transfer** must be submitted:

In order to access the courses after this date, if you are already enrolled in another course of study at this or another university, you must follow the withdrawal and re-enrolment procedures. ## 5. RECOGNITION OF CREDITS FOR CAREER SHORTENING

It is possible to request the recognition of activities and exams taken (including abroad), such as single courses or in previous university careers, so that you do not have to take them again in the course of study. To apply for recognition, you must:

- submit the pre-enrolment application ([point 2](#));
- submit the application for assessment of requirements ([point 3](#)). Within the portal there is a special section for submitting the application for recognition of credits for career shortening; Candidates with a qualification belonging to an old system can refer to the contacts referred to in point 4 for information on this matter. The application for credit recognition can only be submitted after obtaining eligibility for curricular requirements. The deadlines within which to proceed coincide with those indicated for the period of assessment of requirements.

The commission in charge evaluates the application submitted and issues a resolution indicating the year of admission proposed to the chosen degree programme, on the basis of the credits recognized:

For the purposes of counting the credits recognized for the year of admission, only exams already taken and registered by the end of the credit recognition application procedure are considered. After obtaining eligibility for curricular requirements and the resolution to recognize credits, it is possible to proceed with enrolment, change degree programme, incoming transfer or simultaneous enrolment, as indicated on page [www.unipd.it/istruzioniaccesso-triennali-magistrali-ciclounico](http://www.unipd.it/istruzioniaccesso-triennali-magistrali-ciclounico).

The deadlines for proceeding are as follows:

- Application for matriculation: 1 September 2026 – 15 February 2027
- Incoming transfer application: 1 September 2026 – 30 October 2026
- Application for course change: 1 September 2026 – 30 October 2026

It is possible to apply for access to the first year, after obtaining eligibility for the requirements, even if you are still waiting for the resolution to recognize credits.
